**A BILL**

**For an ordinance making a rescission from and an appropriation in the Capital Improvements and Capital Maintenance Fund.**

**WHEREAS**, Ordinance No. 1446, Series of 2022, appropriated funds in the Pavement Markings Capital Program, PI008, to be used towards bike related programs; and

**WHEREAS**, the Denver Moves Implementation Capital Program, PO008, better aligns with the intended use of funds to support the bike paving programs and installation of bikeway projects across the city; and

**WHEREAS**, the City desires to transfer capital program funds to support consolidated management of bike-related programs;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
