A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the United States of America Department of Housing and Urban Development concerning the “Housing Opportunities for People with AIDS (HOPWA) FY22” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the United States of America Department of Housing and Urban Development, for the “Housing Opportunities for People with AIDS FY22” program, which is identified as Grant Number COH22-F001, a copy of which is duly filed with the City Clerk, Filing No. 202265718, be and hereby is approved in all respects.

Section 2. The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Housing Stability, is as follows:

The foregoing authorization will fund the City’s housing, business, and neighborhood development activities to prevent homelessness including appropriate supportive services and resource identification for persons confirmed with AIDS and HIV. Expenditures of said funds are authorized

1 from November 14, 2022 to November 14, 2025 and apply to the January 1, 2022 to December 31,
2 2022 program year.
