This ordinance request is to amend Chapter 42 of the Revised Municipal Code to establish the 2015, 2016 and 2017 salary of the Police Chief, Deputy Chiefs, Division Chiefs and Commanders.

The proposed increase is mirrors the collective bargaining agreement (CBA) with the Denver Police Protective Association. The CBA instituted a 2.5 pay increase in 2015, a 3.5% increase in 2016 and a 2% increase effective January 1, 2017 and another 2% increase effective July 1, 2017. The birthday holiday is also being restored.

Additionally, there is clean up language relating to acting pay regarding commanders acting as Deputy Chiefs.
