8 For an ordinance amending the annual salary of the Director of Excise and Licenses

11 WHEREAS, Colorado Constitution Art. XX, Sec. 2 requires that the compensation of the
12 officers of the City and County of Denver be expressed as a stated salary fixed by ordinance within
13 limits fixed by the Charter; and

15 WHEREAS, in accordance with § 9.2.3 of the Charter the Career Service Board has
16 determined a pay range for the Director of Excise and Licenses, one of the appointed charter
17 officers listed in § 9.2.1 (B) of the Charter; and

19 WHEREAS, the annual salary set forth herein does not exceed the maximum salary set forth in
20 the pay range determined by the Career Service Board, as required by § 9.2.3 of the Charter; and

22 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
23 **DENVER:**

25 **Section 1.** That Chapter 18, Article III, Division 2, Section 18-91 of the Revised Municipal Code
26 is hereby amended by adding the language underlined and deleting the language stricken to read as
27 follows:

29 **Section 18-91. Salaries.**

31 The career service board having determined limits of the salaries of appointed
32 charter officers in accordance with the limitations of section 9.2.3 of the Charter, the
33 council hereby fixes the annual salaries as follows:
