**A BILL**

**For an ordinance authorizing capital equipment purchases from the Airport Enterprise Fund.**

**WHEREAS**, the Department of Aviation (DEN) is seeking approval to purchase vehicles to replace assets which have exceeded their service life and are generating high maintenance and repair costs; and

**WHEREAS**, thirteen (13) of said vehicles are proposed to be replaced with electric zero-emission models; and

**WHEREAS**, the remaining three (3) vehicles will support Denver Police Department (DPD) operations at the airport and must be replaced with like-for-like vehicles due to the operational demands of 24/7 utilization; and

**WHEREAS**, said purchase will be authorized from the Airport Operations & Maintenance Fund (73810); and

**WHEREAS**, said capital equipment items exceed the \$50,000 threshold requiring City Council approval, per the Denver Revised Municipal Code; and

**WHEREAS**, this Ordinance authorizes the purchase of said vehicles;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Airport Enterprise Fund (Accounting No. 73000) the Chief Executive Officer of Aviation, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:

1 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
2 and directed to make such book and record entries and to do such other things as may be necessary  
3 to accomplish the purposes of this Ordinance.
