5 **A BILL**

6 **For an ordinance designating certain property as “park” under section 2.4.5 of**
7 **the city charter, namely the unnamed park located at 51st Avenue and**
8 **Broadway.**

10 **Whereas**, the following real property, known as an unnamed park located at 51st Avenue and
11 Broadway, which is under the jurisdiction of the Denver Department of Parks and Recreation has
12 been or will be used for park purposes within the City and County of Denver (“Park Property”):

13 Lots 9 through 17 inclusive;
14 and the North half of Lot 18;
15 Block 2;
16 R. H. Wren Subdivision.

17 **Whereas**, the Parks and Recreation Advisory Board and the Manager of Parks and Recreation
18 have recommended that said Park Property be formally designated as a “park” under section 2.4.5
19 of the City Charter.

20 **THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

22 **Section 1.** That the Park Property, known as the unnamed park located at 51st Avenue and
23 Broadway, is hereby designated as a “park” under section 2.4.5 of the City Charter and shall
24 henceforth be regarded as being a designated park in the City and County of Denver.
