Land Use, Transportation and Infrastructure

A BILL

For an ordinance approving the Game Plan for a Healthy City 2019, which plan shall supplement the Comprehensive Plan 2040 for the City and County of Denver.

WHEREAS, pursuant to the provisions of Section 12-61 of the Denver Revised Municipal Code (“DRMC”), and by Ordinance No. 19-0302, Series of 2019, there has been approved a Comprehensive Plan for the City and County of Denver (“Comprehensive Plan 2040”); and

WHEREAS, pursuant to the provisions of Section 12-61 of the DRMC, the City wishes to supplement Comprehensive Plan 2040 by approving and accepting the Game Plan for a Healthy City (2019) (“Game Plan”); and

WHEREAS, members of the City Council, duly authorized by the president of council have monitored the process whereby said Game Plan has been formulated; and

WHEREAS, said Section 12-61 of the DRMC provides for supplementing the Comprehensive Plan 2040; and

WHEREAS, the Manager of Community Planning and Development has transmitted the Game Plan to the Mayor and Council for acceptance as a proposed part of the Comprehensive Plan 2040; and

WHEREAS, the Denver Planning Board has approved the same;

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER;

Section 1. That the proposed Game Plan for a Healthy City, consisting of a document of the same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on May 8, 2019, as City Clerk Filing No. 20190038, is hereby accepted and adopted as a supplement to the Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

Section 2. That this adoption and acceptance of the Game Plan, and of any amendment thereto, in conjunction with the Comprehensive Plan 2040, is intended to establish the official guide for officials of the City and County of Denver and private citizens when making decisions affecting the future of and use and transportation in and for the City and County of Denver, as defined in said Game Plan; provided however, that such approval shall not preempt the decision making powers

1 vested by law or administrative directive in the Mayor, the Council or any other official of the City and
2 County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language
3 amendment, a dedication or vacation of a street, alley or other public way, a designation of a park,
4 the issuance of a revocable permit, a conveyance or acquisition of real property by the City and
5 County of Denver, or an appropriation for or construction of a capital improvement; and provided,
6 further that it is expressly understood that judgment must be exercised in the application of the Game
7 Plan in the decision making processes of the Mayor, Council and other officials of the City and
8 County of Denver.
