General description/background of proposed ordinance including contract scope of work if applicable: This agreement is with the Burlington Northern and Santa Fe Railroad (BNSF) for the replacement of a railroad bridge across Sanderson Gulch between Lipan Street and the South Platte River. The agreement secures an easement to replace an existing BNSF bridge with a culvert that will convey the 100-year storm event and includes the cost for BNSF to remove and replace the tracks at this location as part of construction. This agreement supports the Sanderson Gulch project that will construct flood control improvements along Sanderson Gulch to ultimately remove 94 properties from the floodplain.
