16 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
17 Grant Agreement;

18 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
19 **OF DENVER:**

20 **Section 1.** The proposed Grant Agreement, under CFDA No. 16.576, between the State of
21 Colorado and the City and County of Denver, which is identified as Grant No. 17-VC-2, a copy of
22 which is duly filed with the City Clerk, Filing No. 201840072-00, be and hereby is approved in all
23 respects.

24 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
25 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
26 Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal
27 Code of the City and County of Denver.

28 **Section 3.** That it be and is hereby found and determined that the budget summary of said
29 "Crime Victim Compensation" Program, Accounting No. 12250-0401100-CCD0501 is as follows,
