CB10-0629 Approve contract extension with SH&E E-Marketing to provide a common platform to pre-market DIA's concessions and products, provide customer service and add revenue through digital marketing.

This is an extension to an existing contract with SH&E and has two components. This contract provides extension of term and funds to assist DIA with air service development, aviation industry research, and economic impact studies.

Additionally, as a revenue component of the contract SH&E will provide services through web and mobile technology to pre-market and market DIA's concessions and services, provide enhanced customer service and wayfinding ability, and add revenue opportunities on DIA's website and a mobile application.

CR10-0608 A resolution granting a revocable permit to School District No. 1 in the City and County of Denver to encroach into the right-of-way with a retaining wall along East 26th Ave., between Franklin St. and Gilpin St. at Manual High School. (PUBLIC WORKS)

Grants a revocable permit to Denver Public Schools to encroach into the public right-of-way of E. 26th Ave. between Franklin and Gilpin at Manual High School with a retaining wall in Council District 8. This resolution was approved for filing at the Mayor-Council meeting on 7-20-10.

Safety

CR10-0593 A resolution authorizing and approving the expenditure and payment from the appropriation account designated "liability claims," the sum of Eighty Five Thousand Dollars (\$85,000.00), payable to Jaime Solis and Benjamin Silva, III, Esq., in full payment and satisfaction of all claims in Civil Action No. 08-CV-5583, in the Denver District Court. (SAFETY)

Settles a claim involving the Police Department. This resolution was approved for filing at the Mayor-Council meeting on 7-20-2010.

Bills for Introduction-Held in Committee - (Series of 2010)

CB10-0489 A bill for an ordinance adding Sections 1 through 4 to Chapter 17, of the Revised Municipal Code, creating a Fire Department Emergency Services Fee for at-fault non-resident drivers who receive Denver Fire Department Emergency Response Services on State Highways within the City and County of Denver. (SAFETY)

Creates a Denver Fire Department emergency services fee for at-fault non-resident drivers who receive emergency response services on state highways within the City and County of Denver. The Committee approved filing this bill by consent on 6-10-10.

CB10-0570 A bill for an ordinance setting fees for hearings before the Board of Adjustment for zoning appeals. (BLUEPRINT DENVER)

Adopts an updated fee schedule for filings with the Board of Adjustment for Zoning that conforms with the recently adopted zoning code. This bill was approved for filing by Councilwoman Madison.

CB10-0604 A bill for an ordinance designating the Allen M. Ghost Historic District, located generally between the alley between 31st and 32nd Avenues on the north, Lowell Boulevard on the west, 29th Avenue on the south and Irving Street on the east as a district for preservation. (BLUEPRINT DENVER)

Designates an area generally bounded by Lowell, Irving, W. 29th Ave. and W. 32nd Ave. as the Ghost Historic District. PUBLIC HEARING AT LEAST ONE WEEK FOLLOWING PUBLICATION. The Committee approved filing this bill at its meeting on 7-14-10

CB10-0652 A bill for an ordinance setting fees for hearings before the Board of Adjustment for zoning appeals. (BLUEPRINT DENVER)

Establishes a fee schedule for the Board of Adjustment for Zoning. This bill replaces CB10-0570. The Committee approved filing this bill at its meeting on 7-14-10.

Finance

CB10-0560 A bill for an ordinance authorizing the transfer of cash from the Surplus and Deficiency Fund and the Local Improvement District Assessment Fund to the Local Improvement Construction Revolving Fund effective for calendar year 2010 and making an appropriation to the Broadway Streetscape Project. (FINANCE)

Approves transferring the current cash balance of \$425,912 from the Surplus and Deficiency Fund (49000) and the cash balance of \$359,190 from the Local Improvement Assessment Revolving Fund to the Local Improvement Revolving Construction Fund (38081) for the Broadway Streetscape (Iowa to Wesley) project. The funds will be repaid to the City when the assessment from the property owners are paid to the revolving account. The Committee approved filing this bill by consent on 7-1-10.

CB10-0545 A bill for an ordinance rescinding unspent budget from completed 1998 Neighborhood Bond projects and making an appropriation in the 1998 Bond Projects for the Vanderbilt Park Development Project and the Yale/Syracuse Intersection Renovation Project . (FINANCE)

Approves rescinding unspent budgets from completed 1998 Neighborhood Bond Projects and transferring the remaining budgets to two other 1998 bond projects, Vanderbilt Park renovation and Yale/Syracuse Intersection renovation. The Committee approved filing this bill by consent on 7-1-10.

CB10-0587 A bill for an ordinance making rescissions of budget balances to close out grants, and transferring grant cash balances to the General Fund. (FINANCE)

Approves closing out several old grant budgets/fund accounts from completed projects. The Committee approved filing this bill by consent on 7-8-10.

Neighborhood, Community & Business Revitalization

CB10-0600 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Catholic Charities and Community Services of the Archdiocese of Denver, Inc., for the 2010-2011 Temporary Assistance for Needy Families (TANF) program year. (NEIGHBORHOOD COMMUNITY & BUSINESS REVITALIZATION)

Approves a contract with Catholic Charities for the 2010-2011 Temporary Assistance for Needy Families (TANF) program year in the amount of \$672,230. The contract term is July 1, 2010 through June 30, 2011. The last regularly scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent on 7-15-10.

Public Amenities

CB10-0506 A bill for an ordinance approving an amendatory on-call agreement between Consolidated Divisions, Inc. and the City & County of Denver for landscape improvements and irrigation construction services. (PUBLIC AMENITIES)

Corrects the on-call contract with Consolidated Divisions to reflect M/WBE goals of 10% rather than 18%. The last regularly scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent on 6-17-10.

CB10-0510 A bill for an ordinance approving an amendatory on-call agreement between CTM, Inc. d/b/a Colorado Total Maintenance and the City & County of Denver for landscape improvements and irrigation construction services. (PUBLIC AMENITIES)

Corrects the on-call contract with CTM to reflect M/WBE goals of 10% rather than 18%. The last regularly scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent on 6-17-10.

CB10-0509 A bill for an ordinance approving an amendatory on-call agreement between Goodland Construction, Inc. and the City & County of Denver for landscape improvements and irrigation construction services. (PUBLIC AMENITIES)

Corrects the on-call contract with Goodland Construction to reflect M/WBE goals of 10% rather than 18%. The last regularly scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent on 6-17-10.

CB10-0508 A bill for an ordinance approving an amendatory on-call agreement between Richdell Construction, Inc. and the City & County of Denver for landscape improvements and irrigation construction services. (PUBLIC AMENITIES)

Corrects the on-call contract with Richdell Construction to reflect M/WBE goals of 10% rather than 18%. The last regularly scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent

on 6-17-10.

Safety

CB10-0601 A bill for an ordinance approving a program to reimburse the Denver County Court for alcohol evaluation services rendered by the Denver County Court Probation Department between the City and County of Denver and State of Colorado Judicial Department. (SAFETY)

Outlines the agreement by which Colorado Judicial Department reimburses Denver County Court \$ 504,000 for alcohol evaluation services provided by the Denver County Court Probation Department. The last regularly-scheduled Council meeting within the 30-day review period is on 8-16-10. The Committee approved filing this bill by consent on 7-15-10.

CB10-0556 A bill for an Ordinance amending the Old Hire Firefighters Pension Plan to allow members whose status was active on October 2, 1998, to receive pension credit for their additional months of service. (SAFETY)

Approves an amendment to the Denver Old Hire Fire Pension plan to allow for the new calculation of benefits for individuals included in the settlement agreement, Al Sundgren, v. the City and County of Denver. The Committee approved filing this bill by consent on 7-8-10.

CB10-0557 A bill for an Ordinance amending the City and County of Denver Old Hire Fire Pension Plan by removing the requirement that members select a DROP distribution method within 30 days of retirement. (SAFETY)

Removes the requirement in the Old Hire Fire Pension plan that certain individuals select investment options for their DROP funds within 30 days. The Committee approved filing this bill by consent on 7-8-10.

CB10-0558 A bill for an Ordinance amending the City and County of Denver Old Hire Police Pension Plan by removing the requirement that members select a DROP distribution method within 30 days of retirement. (SAFETY)

Removes the requirement in the Old Hire Police Pension plan that certain individuals select investment options for their DROP funds within 30 days. The Committee approved filing this bill by consent on 7-8-10.

CB10-0581 A bill for an Ordinance approving an Intergovernmental Agreement and Lease of a fire station facility to provide fire protection services to the City of Sheridan (SAFETY)

Approves an intergovernmental agreement between Denver and the City of Sheridan under which the Denver Fire Department will provide fire protection services for Sheridan. The last regularly-scheduled Council meeting within the 30-day period is on 8-16-10. The Committee approved filing this bill at its meeting on 7-7-10.

Approves a lease of 12,502 square foot City-owned land at 13th Avenue and Elati Street to GE Johnson Construction Company to use as a construction staging area in the amount of \$7,500 per month for a contract term commencing October 1, 2010 for 24 months. The tenant will pay \$25,000 to the City to defray the cost of restoring the property for future use. The last regularly scheduled Council meeting within the 30-day review period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.

CB10-0583 A bill for an ordinance approving an Agreement between the City and County of Denver and Bridgeman Art Library International to allow the sale of certain copies of art work owned by the Denver Public Library. (PUBLIC AMENITIES)

Approves a 5-year contract allowing Bridgeman Art Library International to market and sell transparencies pieces from the Denver Public Library's art collection, with shared costs and revenues. The last regularly scheduled Council meeting within the 30-day review period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.

CB10-0542 A bill for an Ordinance approving a Development Agreement with LNR CPI High Point, LLC. (PUBLIC AMENITIES)

Approves an agreement providing for the timely and appropriate construction of infrastructure, including parks and recreation facilities, streets, drainage facilities, sanitary sewer facilities and water lines, by defining the responsibilities of all parties involved in development of High Point, northeast of Tower and 64th Ave. in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.

CB10-0589 A bill for an ordinance approving and providing for the execution of a proposed contract between the City and County of Denver and the State of Colorado concerning the "Community Corrections FY10-11" program and the funding therefor. (SAFETY)

Accepts \$13,145,961.36 from the State of Colorado (Division of Criminal Justice and Department of Corrections) for the FY10-11 Community Corrections Programs. The last regularly-scheduled Council meeting within the 30-day period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.

CB10-0576 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and RRK Enterprises d/b/a Independence House for residential and non-residential community corrections services. (SAFETY)

Approves a \$2,717,453 contract with RRK Enterprises Inc. for community corrections services. The last regularly-scheduled Council meeting within the 30-day period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.

CB10-0575 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Correctional Management, Inc. for residential and non-residential community corrections services. (SAFETY)

Approve a \$3,202,048 contract with Correctional Management, Inc. for community corrections services. The last regularly-scheduled Council meeting within the 30-day period is on 8-9-10. The Committee approved filing this bill by consent on 7-8-10.
