Jefferson County Arapahoe County A parcel of land located in the Southeast 1/4 of Section 30, Township 4 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado.

A parcel of land as described in that Quit Claim Deed conveyed to the City & County of Denver, recorded on the 14th of December 1954 in Book 7587 Page 152 in the City and County of Denver Clerk & Recorders Office being more particularly described as follows:

The westerly (30) feet of that portion of Block 13 in Grafton described as follows:
Beginning at the Southeast corner of said Block 13 in Grafton; thence North along the East line of said Block 13, 330 feet to a point; thence West 330 feet more or less to a point on the West line of said Block 13 which is 330 feet North of the Southwest corner of said Block; thence South along the West line of said Block 13, 330 feet to the Southwest corner of said Block; thence East along the South line of said Block 13, 330 feet more or less to the point of beginning.
