

## REVIVAL AND AMENDATORY AGREEMENT

**THIS REVIVAL AND AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado, (the “City”), and **BIG TRUCK RENTAL, LLC** a Florida corporation licensed to do business in Colorado, whose address is 4221 W Boy Scout Blvd., Suite 400, Tampa, Florida, 33607 (the “Contractor”).

### WITNESSETH:

**WHEREAS**, the City and the Contractor previously entered into an Agreement dated February 10, 2025 (the “Agreement”) pursuant to which the Contractor agreed to provide refuse trucks and related products and services on a rental basis; and

**WHEREAS**, the Agreement expired by its terms on October 31, 2025; and

**WHEREAS**, the City intended to have replacement contracts for refuse trucks rental in place but those contracts have been delayed in negotiations so this Amendment is necessary on an emergency basis to maintain the fleet necessary for Solid Waste operations; and

**WHEREAS**, the parties now wish to further amend the Agreement to revive it, [to reflect pricing changes, to add additional types of vehicles to the scope,] to extend its term for an additional period, and to increase the amounts paid to reflect the additional term of services;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth the parties agree as follows:

1. The OMNIA Partners National Cooperative agreement has been extended as shown by the Seventh and Eighth Amendments to the Agreement to Provide Refuse Truck Rentals and Related Products and Services attached hereto and incorporated herein as Exhibit A-1 and all references to “Exhibit A” are hereby amended to read “Exhibits A and A-1 as applicable”

2. The additional Scope of Work is attached hereto and incorporated herein as Exhibit C-1 and all references to “Exhibit C” are hereby amended to read “Exhibits C and C-1 as applicable”.

3. That Article 4 of the Agreement entitled “TERM” is amended to read:

4. TERM: The term of the Agreement shall commence on February 10, 2025 and terminate on December 31, 2026.

4 That Article 5 of the Agreement entitled “COMPENSATION AND PAYMENT” at subparagraph 5.4.1 is amended to read:

5.4.1 Notwithstanding any other provision of this Agreement, the City’s maximum payment obligation will not exceed FOUR MILLION EIGHT HUNDRED TWENTY-SEVEN THOUSAND FIVE HUNDRED DOLLARS AND 00/100 Cents (\$4,827,500.00) (the “Maximum Contract Amount”). The City is not obligated to execute an Agreement, Task Order, or any amendments for any further services, including any service performed by the Contractor beyond that specifically described in Exhibits C and C-1 as applicable. Any services performed beyond those in Exhibits C and C-1 as applicable are performed at the Contractor’s risk and without authorization under this Agreement.

5. Except as herein amended, the Agreement is revived, affirmed and ratified in each and every particular.



**SEVENTH AMENDMENT TO THE AGREEMENT TO PROVIDE  
REFUSE TRUCK RENTALS AND RELATED PRODUCTS AND SERVICES**

**THIS SEVENTH AMENDMENT TO THE AGREEMENT TO PROVIDE REFUSE TRUCK RENTALS AND RELATED PRODUCTS AND SERVICES** (this "Seventh Amendment") is made and entered into this 14 of February 2025 by and between Big Truck Rental LLC, a Florida limited liability company doing business in North Carolina (the "Company"), and the City of Charlotte, a North Carolina municipal corporation (the "City").

**Statement of Background and Intent**

- A. The City of Charlotte and the Company entered into an Agreement for Refuse Truck Rentals and related Products and Services dated November 1, 2018 (the "Contract") pursuant to which the company agreed to provide Refuse Truck Rentals and Related Products and Services for the City of Charlotte.
- B. The parties amended the Contract to incorporate unit price adjustments to the Discount Schedule, Additional Fees, and Incentives.
- C. The parties amended the Contract to add and delete products, to incorporate unit price adjustments to the Discount Schedule, Additional Fees, and Incentives, and to replace the Commercial Non-Discrimination clause.
- D. The parties amended the Contract to make adjustments to the Discount Schedule, Additional Fees, and Incentives and to incorporate certain other changes.
- E. The parties amended the Contract to add and delete products, to make price adjustments to the Discount Schedule, Additional Fees, and Incentives, and to incorporate certain other changes.
- F. The parties amended the Contract to extend the Term of the Contract by the first of two (2) two-year and to incorporate certain other changes.
- G. The parties amended the Contract to incorporate unit price adjustments to the Discount Schedule, and Additional Fees, and to incorporate certain other changes.
- H. The parties now desire to amend the Contract to incorporate additional products and to incorporate certain other changes.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreement contained herein, the parties hereby agree to the following:

**AGREEMENT**

- 1. The terms of the Contract are restated by and incorporated into this Seventh Amendment by reference.
- 2. Defined terms used in this Seventh Amendment shall have the same meaning as are assigned to such terms in the Contract.
- 3. The Discount Schedule, Additional Fees, and Incentives in Exhibit A of the Contract are hereby replaced in its entirety due to additional products being added, which are attached hereto as Exhibit A.6.


