1. Tell us about your expertise in the immigrant or refugee community in Denver

I have lived in Denver almost my entire life. As a Palestinian woman, I have firsthand lived experience of refugee struggles that permeate across generations. I vividly remember attempting to navigate various governmental offices for my parents, who didn't speak English, at only eight years old, reaching out to food banks from the yellow pages, and watching my mom truly 'hustle' to make ends meet for my sister and I who were living in a car down Colfax. She was accepted into the country and simultaneously deserted, left without proper resources to navigate day-to-day.

2. Tell us about your expertise in your professional field.

Working in service with immigrants and refugees for over ten years has been the highlight of my life. Growing up, I heard the frustrations of women, who, despite their inclusion of constitutional rights, lacked local political participation and found advancement in education or a professional career insurmountable due to societal and familial pressures. Volunteering with small business owners in Surin, Thailand, I saw the injustices and near extinction of sugar cane farms due to the rapid expansion of agribusiness and the inequitable dissemination of technological information.

3. What strengths do you feel you bring to the Commission?

Incorporating community voices through a strong diversity, equity, and inclusion lens that amplifies their story and perspective, not tokenize it. I attempt to cultivate spaces where individuals feel safe, valued and heard. I am also a certified Intercultural Development Inventory administrator, a beautiful tool to gauge how an individual experiences their own identity in relation to those around them and vice-versa. I would love to facilitate this for DIRC and community members alike. It offers the opportunity for robust dialogue and allows an individual insight into their

4. What are the biggest challenges you see facing immigrant and refugee communities in Denver?

Societal rhetoric and perception of immigrants and refugees generalize narratives that dehumanize and homogenize experiences, stagnating policy implementation. Rising racial tensions create additional barriers to already inaccessible programs. A lack of access looks like transportation, language & communication, technology, unsafe spaces, or a fear of retaliation.

Forced displacement is moving majority immigrant and refugee communities either out of their homes, priced out of

5. What are some of the issues or opportunities in Denver that immigrants & refugees can address together?

There are strengths in numbers and within community. Intentionally curated spaces for individuals with common identities leads to natural ideation of experiences and innovative solutions.

Generational trauma and imposter syndrome are symptoms from decades of discrimination, war, unjust policies, and so much more. Communal healing is a powerful tool and can be done in a variety of ways. Facilitated conversations, healing circles, mindfulness and yoga, are some that I have personally conducted with women across Morocco, Jordan, and the US.

6. How do you engage with a person whose opinions are different than your own?

I love hearing other individuals' stories. To just sit and hear about their struggles, triumphs, dreams, and goals. As a Palestinian, I have been forced into a political identity in all spaces. I have learned how to engage individuals whose perspectives diverge and truly listen to the why of their beliefs, having passionate, and productive dialogue where all are heard, and no one is superior. I find myself as a drop in someone's bucket and vice-versa. Anti-oppression, anti-racist, justice work requires co-creation and intent of us all. However, when I shifted my focus to understanding,

7. Describe a project or initiative in your field of expertise that you led or played a significant role in, and what was the result.

When I lived in Morocco, I spent the first year listening and engaging with my community. A need they identified was a space for women to safely gather, without the male gaze, and they could exercise. We held meetings with different governmental entities, and arranged for the women to use a local Dar Chabab. We began hosting exercise classes nearly every day of the week as they continued to grow in popularity and even neighboring towns. This evolved into a space of empowerment. Organically our exercise classes evolved into structured conversations around the importance

8. Describe a project or initiative in your community that you led or played a significant role in, and what was the result.

As those stories above, I have been impacted by unjust systems, discriminatory rhetoric, and a lack of representation around me that have created additional barriers on my path. I have learned from my experience and been inspired by communities around the world for the need to intentionally create equitable systems and processes with marginalized identities at the forefront. I have conducted multiple equity audits with nonprofits in Morocco and the US. Together we worked to identify gaps in Diversity, Equity, Inclusion, Access, Accountability, and Justice (DEIAAJ) that resided
