**ABILL**

**For an ordinance approving and accepting the park building plan for the maintenance and operations facility, equipment building, and storage building, all located in City of Cuernavaca Park, pursuant to the provisions of Sections 39-210 and 39-211 of the Denver Revised Municipal Code.**

**WHEREAS**, pursuant to the provisions of Sections 39-210 and 39-211 of the Denver Revised Municipal Code (“DRMC”), the Department of Parks and Recreation submitted to City Council for approval the building plan for a maintenance and operations facility, for an equipment building, and for a storage building, all located in City of Cuernavaca Park; and
