5 **To set a public hearing relating to the adoption of the 101 Broadway Urban**
6 **Redevelopment Plan and directing the Denver Urban Renewal Authority to take**
7 **certain actions in connection with the hearing.**

9 **WHEREAS**, the City Council desires to set a public hearing on the adoption of the 101
10 Broadway Urban Redevelopment Plan pursuant to C.R.S. § 31-25-107(3); and

11 **WHEREAS**, City Council desires to delegate the responsibility for notice to DURA.

12 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
13 **OF DENVER:**

14 **Section 1.** Date, Time and Location of the 101 Broadway Urban Redevelopment Plan
15 Public Hearing. The City Council shall conduct a public hearing on the 101 Broadway Urban
16 Redevelopment Plan. The public hearing shall be on Monday, June 25, 2018, at 5:30 p.m. in Council
17 Chambers in the City and County Building located at 1437 Bannock Street, in Denver, Colorado.

18 **Section 2.** Other Actions and Notices. DURA is delegated the authority and directed to
19 give all written notices and publications required by C.R.S. § 31-25-107, including those required
20 under C.R.S. § 31-25-107(9.5).

21 **Section 3** Plan Submittal. That the 101 Broadway Urban Redevelopment Plan be
22 submitted to the City Council and Board of Equalization of the City, sitting as the Board of County
23 Commissioners in accordance with the Charter of the City.

24 **Section 4.** That the Clerk of the City and County of Denver shall attest and affix the seal of
25 the City and County of Denver to this Resolution.
