A RESOLUTION

Laying out, opening and establishing as part of the City street system a parcel of land as a public alley bounded by Galapago Street, Fox Street, West Ellsworth Avenue and West 1st Avenue.

WHEREAS, the Executive Director of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public alley designated as part of the system of thoroughfares of the municipality those portions of real property hereinafter more particularly described, and, subject to approval by resolution has laid out, opened and established the same as a public alley;

BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Executive Director of Public Works in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portion of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

PARCEL DESCRIPTION ROW NO. 2016-DEDICATION-0000162-001:

A parcel of land conveyed to the City of Denver by Quit Claim Deed, recorded on the 12th of January 1901, in Book 1422, Page 18, in the Clerk & Recorder’s Office, City & County of Denver, said parcel of land being located in the Southwest 1/4 of Section 10, Township 4 South, Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, and being more particularly described as follows:

The rear eight (8) feet of Lots numbered eleven (11) to twenty-eight (28) all inclusive, Block numbered four (4) , in Lake Archer Subdivision to the City of Denver, making a strip of ground sixteen (16) feet in width, said strip to be used as an alley by the City of Denver, and the public.

be and the same is hereby approved and said real property is hereby laid out and established and declared laid out, opened and established as a public alley.

Section 2. That the real property described in Section 1 hereof shall henceforth be a public alley.
