CB14-0607 A bill for an ordinance approving a proposed third amendment to agreement between the City and County of Denver and AMPCO System Parking dba ABM Parking Services concerning shuttle bus services at Denver International Airport.

Amends a contract with ABM Parking Services by increasing the maximum contract amount by \$39,752,762 for a new total of \$173,211,705, and extending the term by two (2) years for a maximum term of nine (9) years for shuttle bus management services at Denver International Airport (CE 78003). ABM Parking Services proposed 10.6% Airport Concession Disadvantaged Business Enterprise (ACDBE) participation. The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this at its meeting on 8-19-14.

CB14-0616 A bill for an ordinance approving a proposed loan agreement between the City and County of Denver and Colorado Health & Science Ecosystem LLC, to finance a portion of the acquisition of a property located at 3825 Lafayette Street to be developed into a health collaborative office and mixed-use facility.

Approves a \$1 million loan to Colorado Health & Science Ecosystem, LLC that will expire on 10-1-19 to finance a portion of the acquisition of a property located at 3825 Lafayette Street to be developed into a health collaborative office and mixed-use facility in Council District 8. The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill at its meeting on 8-19-14.

CB14-0619 A bill for an ordinance approving a proposed second amendment to parking management contract between the City and County of Denver and SP Plus Corporation fka Standard Parking Corporation concerning public parking facilities at Denver International Airport.

Amends a contract with SP Plus Corporation to add 18 months for a new end date of 3-30-16 to provide all phases of the parking management services at the Hotel and Transit Center at Denver International Airport in conjunction with the hotel's opening with no cost increase to the City (CE 85002). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee

approved filing this at its meeting on 8-19-14.

CB14-0641 A bill for an ordinance approving a proposed first amendment to agreement between the City and County of Denver and Metrix Advisors, LLC concerning the Premium Value Concession Program at Denver International Airport.

Amends a contract with Metrix Advisors, LLC to add \$913,000 for a new total contract of \$2.64 million to provide additional responsibilities as the Premium Value Concessions (PVC) program's Third Party Administrator at Denver International Airport (201205015(1)). The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill at its meeting on 8-27-14.

CB14-0642 A bill for an ordinance approving a proposed Standard Specialty Retail Concession Space Agreement between the City and County of Denver and Denver Duty Free JV, a Colorado Joint Venture among Wystone's World Teas Holdings Inc., Odd Tale Books, LLC and Dufry North American, LLC for three concessions at Denver International Airport.

Approves an agreement with Denver Duty Free JV for a period of seven years and \$116,799.34 monthly to develop, operate, and manage the new Tax & Duty Free/Duty Paid locations in Concourse A Center Core and in Concourse B, Mezzanine Level East-side, along with a specialty retail location in Concourse C Center Core at Denver International Airport (PLANE 201415388-00). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill at its meeting on 8-27-14.

CB14-0659 A bill for an ordinance approving a proposed third amendment to agreement between the City and County of Denver and reVision, Inc. related to on-call information technology consulting services at Denver International Airport.

Amends an agreement with reVision, Inc. to add \$3 million for a new contract total of \$14.5 million for continuity of service for three major long-term technology programs to be accomplished and designed over the next two years at Denver International Airport (CE05038-03). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-21-14.

CB14-0660 A bill for an ordinance approving a proposed second amendment to agreement between the City and County of Denver and Insight Global, Inc. related to on-call technology systems support services at Denver International Airport.

Amends a contract with Insight Global, Inc. to add one year through 10-4-15 and to add \$718,600 for a new contract total of \$2,218,600 for on-call technical professional services to the Portfolio & Project Management Office, Applications Team, and the Network Engineering Group at Denver International Airport (201100104). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on

8-21-14.

CB14-0681 A bill for an ordinance approving a proposed first amendment to contract between the City and County of Denver and Sturgeon Electric Company, Inc., related to runway lighting rehabilitation at Denver International Airport.

Amends the contract with Sturgeon Electric Co., Inc. by adding \$1,536,883.30 for a new contract total of \$9,440,965.07 for maintenance and repairs including removing and replacing runway and taxiway centerline lights, touchdown zone lights, stop bar lights, edge lights, transformers, and cabling on the RW 8-26 complex including portions of Taxiways EE, L, M, and Z at Denver International Airport (201313528). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-21-14.

CB14-0686 A bill for an ordinance approving a proposed 2014 Lease Amendment to the Airport Use and Facilities Lease Agreement between the City and County of Denver and United Airlines, Inc., related to leased space at Denver International Airport.

Amends the contract with United Airlines by decreasing its unused leased space in return for an additional 10 years to the lease term. The total United lease term will be a total of 40 years expiring on 2-28-35 (XC 2X000-07). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill at its meeting on 8-19-14.

CB14-0668 A bill for an ordinance approving an Amendatory Agreement with Compass Group USA, Inc. for City vending machine service.

Extends the current revenue contract with Compass Group USA for City vending machine service through 12-31-14 (RC96003). The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0695 A bill for an ordinance approving a Purchase and Sale Agreement between DP Assets, LLC and the City and County of Denver for the sale of City owned property located at 3744 Lipan Street.

Approves the sale of approximately 1,475 square feet of City-owned real estate located approximately at West 38th Avenue and Lipan Street in Council District 9 to DP Assets, LLC for \$20,000. The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0634 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and SP Plus Corporation for professional parking management services for three City-owned public parking garages.

Approves a three-year, \$4,435,107 contract with SP Plus Corporation for professional parking management services for three City-owned public parking garages: Denver Justice Center Garage, Cultural Center Complex, and Denver Performing Arts Complex (201417250). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-14-14.

CB14-0663 A bill for an ordinance approving an Agreement between the City and County of Denver and Barker Rinker Seacat Architecture, P.C. for the Central Denver Recreation Center Project.

Approves a \$1,584,032.50, three-year agreement with Barker Rinker Seacat Architecture for the architectural and engineering design services for the new Central Denver Recreation Center located at 2405 East Colfax Avenue in Council District 8 (201417595). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-14-14.

CB14-0666 A bill for an ordinance approving an Agreement (Broadway Arizona-Kentucky Project) between H.C. Peck and Associates, Inc. and the City and County of Denver for the Broadway Arizona-Kentucky Project.

Approves a \$5,945,000 agreement with H.C. Peck and Associates through 12-31-17 for real estate consulting services for the South Broadway Reconstruction Project - Arizona-Kentucky including acquisition and relocation services in Council District 7 (FINAN 201417289). The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0684 A bill for an ordinance approving a Parks Use Agreement with The German American Chamber of Commerce – Colorado Chapter for use of a portion of Skyline Park for holding a multi-day event for more than thirty days.

Authorizes a Park Use Agreement expiring on 12-31-14 with The German American Chamber of Commerce – Colorado Chapter in the amount of \$13,461.25 for the use of Skyline Park as the venue for the annual Christkindle market multi-day event (201417104). The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0691 A bill for an ordinance approving a Grant of Easement-Storm Water System with Town Center Metropolitan District to construct a storm sewer system across the High Line Trail Corridor.

Grants an easement to Town Center Metro District for the installation and operation of a storm sewer outfall system across City property and the High Line Canal Trail in Green Valley Ranch, located in Council District 11 (201417368). The last

regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0697 A bill for an ordinance approving a contract with Jacobs Investment LLC dba Colorado Boring Company for Citywide Traffic Signal Improvements.

Approves a \$760,454.33, 6-month contract with Colorado Boring Company for signal system improvements at various locations City-wide (201416666). The last regularly scheduled Council meeting within the 30-day review period is on 9-29-14. The Committee approved filing this bill by consent on 8-28-14.

CB14-0698 A bill for an ordinance amending section 39-121 of the Revised Municipal Code changing various fees and charges for the Zoo, in the Department of Parks and Recreation.

Approves an increase in certain admission and facility rental fees at the Denver Zoo (XC40345). The Committee approved filing this bill at its meeting on 8-27-14.

Neighborhoods & Planning

CB14-0665 A bill for an ordinance designating 227 South Lincoln Street, the Gulliver-Lynch House, as a structure for preservation.

Approves the designation of 227 South Lincoln Street as an individual structure for preservation in Council District 7. A PUBLIC HEARING WILL BE HELD AT LEAST ONE WEEK AFTER PUBLICATION. The Committee approved filing this bill at its meeting on 8-20-14.

CB14-0670 A bill for an ordinance changing the zoning classification for 2728 Zuni Street and 2751 Wyandot Street.

Rezones the parcel located at 2728 Zuni Street & 2751 Wyandot Street from Planned Unit Development (PUD) 437 to C-MX-5 (Urban Center, Mixed Use, 5 stories) in Council District 9. A PUBLIC HEARING WILL BE HELD AT LEAST FOUR WEEKS AFTER PUBLICATION. The Committee approved filing this bill at its meeting on 8-20-14.

Safety & Well-being

CB14-0652 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States concerning the "Emergency Solutions Grant (ESG) FY14" program and the funding therefor.

Accepts the Emergency Solutions Grant awarded by the U.S. Department of Housing and Urban Development in the amount of \$582,503 for fiscal year 2014, to address and prevent homelessness (SOCSV-2014-17428-00). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-21-14.

CB14-0655 A bill for an ordinance approving a Fourth Amendatory Agreement between the City and County of Denver and the State of Colorado Department of Corrections to provide hemo dialysis treatment at the Denver County Jail.

Amends a contract with the Colorado Department of Corrections by extending the term an additional year to provide out-patient Hemo-Dialysis and related services to incarcerated patients held within the custody of the Denver Sheriff Department at a rate of \$335 per patient treatment (CE91216-4). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-21-14.

CB14-0656 A bill for an ordinance authorizing expenditures in the Public Safety Special Revenue Fund based on a letter of intent from the Office of National Drug Control Policy to award funding for the "High Intensity Drug Trafficking Area (H.I.D.T.A) FY15" program.

Authorizes expenditures totaling \$596,935 in the Public Safety Special Revenue Fund based on a letter of intent from the Office of National Drug Control Policy to award funding for the "High Intensity Drug Trafficking Area (H.I.D.T.A.) FY15" program (POLIC-201417418-00). The Committee approved filing this bill by consent on 8-21-14.

CB14-0657 A bill for an ordinance approving a Second Amendatory Intergovernmental Agreement between the City and County of Denver and School District No. 1 for the provision of School Resource Officers during the 2014-2015 school year.

Amends an Intergovernmental Agreement with Denver Public Schools for the provision of School Resource Officers to add a third year, the 2014-2015 school year, and adding \$643,714 revenue for that period, bringing the three-year revenue total to \$1,922,074 (201209123-02). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 8-21-14.

Technology & Governance

CB14-0671 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

Amends the Classification and Pay Plan by changing the Aviation Noise Abatement Officer classification Fair Labor Standards Act status from non-exempt to exempt and the pay grade from 623-E to 811-E. The Committee approved filing this bill by consent on 8-28-14.

CB14-0672 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

Amends the Classification and Pay Plan by adding the classifications of Deputy Public Defender I 807-L (\$45,057-\$72,091), Deputy Public Defender II 809-L

(\$51,489-\$82,382) and Chief Municipal Public Defender 816-L (\$82,142-\$131,427). The Committee approved filing this bill by consent on 8-28-14.

Land Use, Transportation & Infrastructure

CB14-0313 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and WM Curbside, LLC, to increase the funding and extend the term of the Agreement.

Amends a contract with WM Curbside, LLC to extend through 4-8-15 and increase the contract amount by \$151,000 for a total contract amount of \$604,450 to provide City-wide residential collection of household hazardous waste (201100433-03). The last regularly scheduled Council meeting within the 30-day review period is on 9-22-14. The Committee approved filing this bill by consent on 4-17-14.

CB14-0596 A bill for an ordinance approving an Agreement between Revision International and the City and County of Denver to utilize funds for acquisition of the property at 3738 Morrison Road with the intention of developing a neighborhood food hub.

Approves a \$1.2 million contract with Revision International (in Community Development funds) through 3-31-15 to acquire 3738 Morrison Road for a neighborhood-serving food HUB/grocery store in Council District 3. The last regularly scheduled Council meeting within the 30-day review period is on 9-8-14. The Committee approved filing this bill at its meeting on 8-5-14.

Finance & Services

CB14-0620 A bill for an ordinance establishing a "Revolving Affordable Housing Loan" fund in the Community Development Special Revenue Fund and the means for authorizing expenditures from such fund.

Approves the creation of a Special Revenue Fund serving as a revolving loan fund for the specific purpose of creating new affordable housing for the workforce rental population in Denver. The Committee approved filing this bill at its meeting on 8-12-14.

CB14-0629 A bill for an ordinance approving an agreement with DP Assets, LLC for the sale of 695 Water Street for \$1.53 million dollars.

Approves a purchase and sale agreement with DP Asset, LLC for the sale of 695 Water Street for \$1.53 million in Council District 1 (FINAN-201415486-00). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. The Committee approved filing this bill by consent on 8-14-14.

Infrastructure & Culture

CB14-0638 A bill for an ordinance vacating the eastern portion of an alley located between Corona Street, Downing Street, 14th Avenue and Colfax Avenue, with reservations.

Approves the permanent vacation of a portion of an alley between Corona Street, Downing Street, 14th Avenue, and Colfax Avenue (The East Colfax Marketplace) in Council District 10. The Committee approved filing this bill by consent on 8-14-14.

CB14-0639 A bill for an ordinance approving a Revival and Fourth Amendatory Contract between the City and County of Denver and Jacobs Investments, LLC, d/b/a Colorado Boring Co., to extend the term of the Contract for an additional year and increase the maximum contract amount.

Adds \$1 million to and extends the contract with Colorado Boring Company (for a new maximum amount of \$3.8 million through 5-15-15) for on-call directional boring services (OC91391). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. The Committee approved filing this bill by consent on 8-14-14.

CB14-0650 A bill for an ordinance approving a proposed Amendment to Agreement between the City and County of Denver and Urban Drainage and Flood Control District regarding final design, right-of-way acquisition and construction of drainage and flood control improvements along Lakewood Gulch, Wolff Street to Sheridan Boulevard.

Amends an Intergovernmental Agreement (IGA) with the Urban Drainage and Flood Control District (UDFCD) to utilize \$250,000 in UDFCD funding to update the design of an open channel reconstruction project and fund a right-of-way acquisition from Wolff Street to Sheridan Boulevard on Lakewood Gulch in Council District 3 (CE80221-01). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. The Committee approved filing this bill by consent on 8-14-14.

Technology & Governance

CB14-0606 A bill for an ordinance approving a proposed Purchase Order between the City and County of Denver and Insight Public Sector, Inc., for Oracle database maintenance and support.

Approves a \$575,943.20 payment to Insight Public Sector for annual Oracle

database maintenance and support through 8-29-15 (EAPPS0000004153). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. Committee approved filing this bill by consent on 8-14-14.

CB14-0633 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Versaterm, Inc., to extend the contract and add additional funds to provide maintenance and support to the Records Management System.

Amends a contract with Versaterm, Inc. to add three years through 12-31-17, and \$1,663,752, for a new contract total of \$4,342,956, to provide maintenance and support to the Records Management System used by Police, City Attorney, District Attorney, Sheriff Department, and County Courts (CE83108). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. The Committee approved filing this bill by consent on 8-14-14.

CB14-0636 A bill for an ordinance authorizing the purchase of capital equipment from the Technology Services Capital Projects Fund.

Approves a \$121,500 purchase order for Accuvant for a second Internet Portal URL Filter Appliance to provide redundancy, security, and more bandwidth. The Committee approved filing this bill by consent on 8-14-14.

CB14-0645 A bill for an Ordinance approving a proposed purchase by the City and County of Denver ("City") of insurance coverage from: Kaiser Foundation Health Plan of Colorado; UnitedHealthCare Insurance Company; Denver Health Medical Plan, Inc.; Delta Dental of Colorado; Standard Insurance Company of Colorado, Inc.; Vision Service Plan Insurance Company.

Approves the recommended 2015 changes to the City and County of Denver's employee health insurance plans. The Committee approved filing this bill at its meeting on 8-12-14.

CB14-0646 A bill for an ordinance amending Sections 18-171, 18-172, 18-173, 18-174, 18-175, and 18-176 of Chapter 18, of the Revised Municipal Code, changing the City's participation in medical insurance plans and contributions to implement the Patient Protection and Affordable Care Act.

Approves changes to the City's participation in medical insurance plans and contributions in compliance with the Patient Protection and Affordable Care Act. The Committee approved filing this bill at its meeting on 8-12-14.

Government & Finance

CB14-0513 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Qwest Communications Company, LLC d/b/a CenturyLink QCC, to extend the term and increase the maximum contract amount.

Adds \$7.5 million to the contract with CenturyLink QCC and extends the term through 8-31-18 (for a new contract total of \$20 million) for additional services and

a greater discount on voice and data services (TECHS-CE95035). The last regularly scheduled Council meeting within the 30-day review period is on 9-15-14. The Committee approved filing this bill by consent on 6-19-14.

Health, Safety, Education & Services

CB14-0550 A bill for an ordinance approving an agreement between the City and County of Denver and Community Education Centers, Inc. for residential and non-residential community corrections services.
