5 **Approving and providing for the execution of a proposed amended Grant**
6 **Agreement between the City and County of Denver and the Department of**
7 **Justice (DOJ), Office of Justice Programs, Bureau of Justice Assistance**
8 **concerning the “Denver Cold Case Collaborative” program and the funding**
9 **therefor.**

11 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
12 Grant Agreement;

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
15 **OF DENVER:**

17 **Section 1.** The proposed amended Grant Agreement between the City and County of Denver
18 and the Department of Justice (DOJ), Office of Justice Programs, Bureau of Justice Assistance, for
19 the “Denver Cold Case Collaborative” program, which is identified as Grant Number 15PBJA-23-
20 GG-02275-DNAX, a copy of which is duly filed with the City Clerk, Filing No. 202371407, be and
21 hereby is approved in all respects.

22 **Section 2.** The payments made by the Department of Justice (DOJ), Office of Justice
23 Programs, Bureau of Justice Assistance, to the City pursuant to and under the amended Grant
24 Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund
25 No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the
26 City and County of Denver.

27 **Section 3.** That it be and is hereby found and determined that the budget summary of said
28 program, to be expended by the District Attorney, is as follows:
