4 **A RESOLUTION**

5 **To set a public hearing relating to the I-25 and Broadway Urban Redevelopment**
6 **Plan and directing the Denver Urban Renewal Authority to take certain actions**
7 **in connection with the hearing.**

8 **WHEREAS**, the City Council desires to set a public hearing on the adoption of the I-25 and
9 Broadway Urban Redevelopment Plan pursuant to C.R.S. section 31-25-107(3); and

10 **WHEREAS**, City Council desires to delegate the responsibility for notice to Denver Urban
11 Renewal Authority (“DURA”).

12 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 **Section 1.** Date, Time and Location of the I-25 and Broadway Urban Redevelopment Plan
14 Public Hearing. The City Council shall conduct a public hearing on the I-25 and Broadway Urban
15 Redevelopment Plan. The public hearing shall be on Monday October 2, 2017, at 5:30 p.m. in
16 Council Chambers in the City and County Building located at 1437 Bannock Street, in Denver,
17 Colorado.

18 **Section 2.** Other Actions and Notices. DURA is delegated the authority and directed to
19 give all written notices and publications required by C.R.S. § 31-25-107, including those required
20 under C.R.S. § 31-25-107(9.5).

21 **Section 3** Plan Submittal. That the I-25 and Broadway Urban Redevelopment Plan be
22 submitted to the City Council and Board of Equalization of the City, sitting as the Board of County
23 Commissioners in accordance with the Charter of the City.

24 **Section 4.** That the Clerk of the City and County of Denver shall attest and affix the seal of
25 the City and County of Denver to this Resolution.
