A BILL

For an ordinance making a rescission from General Fund Contingency and making appropriations to agency General Fund, Special Revenue Funds, Capital Funds, and Enterprise Funds.

WHEREAS, General Services requests \$3,300,000 to cover increases to security and janitorial contracts and pay equity audit increases that were not in the 2022 budget; and

WHEREAS, the Fire Department requests \$3,000,000 to support costs related to unbudgeted Collective Bargaining Agreements and additional recruits; and

WHEREAS, the City Attorney's Office requests \$1,662,377 to replenish the Liability and Claims Fund for approved claims paid between June -September 2022; and

WHEREAS, Parks and Recreation requests \$1,468,837 for water expenses; and

WHEREAS, Technology Services requests \$1,225,000 for a Salesforce program for a contracting system to track housing contracts in the Department of Housing Stability; and

WHEREAS, the Department of Finance requests \$1,117,000 to for replacement of totaled DPD, DFD, DOTI & CPD vehicles, to be purchased from the Risk Management Fund; and

WHEREAS, the Department of Finance requests \$345,000 for an appropriated payment to DURA for the Colorado National Bank Hotel TIF, related to 2021 expenses; and

WHEREAS, the Civil Service Commission requests \$100,000 to support cost related to timely background checks and psychological evaluations; and

WHEREAS, the Denver Health and Hospital Authority DDPHE-Park Hill Payment Fund requires \$100,000 for costs related to increased interest and a delayed invoice from 2021; and

WHEREAS, the Office of Social Equity and Innovation requests \$75,000 to cover increases to personnel from a pay equity audits and audit response support; and

WHEREAS, the Office of Special Events requests \$50,000 for unbudgeted pay equity audits; and

WHEREAS, the Planned Fleet Special Revenue Fund requests \$45,000 for the purchase of van for safe removal of propane that was not budgeted for 2022; and

WHEREAS, the Board of Ethics requires \$25,000 for unbudgeted personnel expenses; and

1 **WHEREAS**, the City’s Internal Billings and Reimbursements Special Revenue Fund
2 requires a total increase of \$3,000,000 for increased Police and Fire personnel costs at the Airport
3 due to overtime and separation payouts; and

4 **WHEREAS**, the Denver Airport requests \$2,500,000 from the Aviation Hotel Enterprise
5 Fund due to increased occupancy rates resulting in increased revenue and increased costs that
6 are not budgeted; and

7 **WHEREAS**, Parks and Recreation requests \$500,000 from the Golf Enterprise for increased
8 labor needs and inflation; and

9 **WHEREAS**, Denver Arts and Venues requests \$5,000,000 due to increased events and
10 attendance over what was previously budgeted including stagehands, janitorial services, ushers,
11 security expenses;

13 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

16 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in
