SEVENTH AMENDMENT TO AGREEMENT

THIS SEVENTH AMENDMENT TO AGREEMENT is made and entered into as of the date stated on the City's signature page below, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado, for and on behalf of the Department of Aviation (the "City"), and WORLD CONCOURSE VENTURES, LLC, a limited liability company formed under the laws of the State of Delaware and authorized to conduct business in the State of Colorado, d/b/a Hudson Booksellers ("Concessionaire").

WITNESSETH:

WHEREAS, the Parties hereto entered into an agreement (AC-37004) dated April 9, 1993, which together with six prior amendments to the agreement is hereafter referred to as the "Existing Agreement," for the operation of a concession at Denver International Airport ("DIA"); and

WHEREAS, due to the fact that a contract for a different concession to lease the space currently occupied by Concessionaire has been delayed; and

WHEREAS, the City finds it to be in its best interest to have Concessionaire remain in the Concession Space to continue to serve the traveling public during the negotiation of and City Council approval process for the new concession; and

WHEREAS, the Parties have agreed to waive the additional fee associated with holding over under the Existing Agreement:

NOW, THEREFORE, for the foregoing reasons and for other good and valuable consideration, the sufficiency of which is acknowledged, the parties hereby agree to amend the Existing Agreement as follows:

1. Section 4.03, Holding Over, of the Existing Agreement is hereby amended by deleting it entirely and substituting the following:

4.03 HOLDING OVER

The parties agree that nothing herein shall be construed to give Concessionaire the right to hold over at any time, and the City (after expiration or termination of this Agreement), as the case may be, may exercise any and all remedies at law or in equity to recover possession of the Concession Space, as well as any damages incurred by City on account of such holding over.

However, Concessionaire has been given permission to holdover after the expiration of this Agreement. Concessionaire's occupancy shall be deemed by the City to be a month-to-month holdover tenancy, at a monthly rental, payable in advance, equal to the monthly Compensation provided in Section 5 herein, and Concessionaire shall remain bound by all terms, conditions, covenants, and agreements hereof. Concessionaire and the City agree that the tenancy shall be may be terminated at any

time by thirty (30) days prior written notice from either Party to the other, or such shorter time as may be agreed upon by the Parties.

- 2. Except as modified or revised herein, all terms, conditions, covenants and provisions of the Original Agreement shall remain in full force and effect as if fully set forth herein and the Original Agreement hereby is revived, confirmed and ratified in all respects.
- 3. This Seventh Amendment to Agreement is expressly subject to and shall not be or become effective or binding on the City until fully executed by all signatories of the City and County of Denver.
