1 BY AUTHORITY 2 ORDINANCE NO. _____ COUNCIL BILL NO. CB25-1992 3 SERIES OF 2025 COMMITTEE OF REFERENCE: 4 Community Planning and Housing 5 ABILL 6 For an ordinance designating 1555 North Grant Street as a structure for 7 preservation. 8 WHEREAS, pursuant to Section 30-4, Denver Revised Municipal Code, the Landmark 9 Preservation Commission has transmitted to the Council a proposed designation of a structure for 10 preservation; and 11 WHEREAS, based upon evidence received by the Landmark Preservation Commission at a 12 hearing on December 2, 2025, the staff report, and evidence received at the hearing before City Council 13 on December 15, 2025, the structures at 1555 North Grant Street meets the criteria for designation as a structure for preservation as set out in Section 30-3, Denver Revised Municipal Code, as amended, 14 15 by maintaining its integrity, being more than 30 years old, and meeting the criteria in the following four categories from Section 30-3(3): 16 17 b. Having direct and substantial association with a recognized person or group of persons 18 who had influence on society; 19 The structures at 1555 North Grant Street are associated with Knights of Columbus District 539, which served both Denver's Catholic community as well as the greater community at-large, and their location 20 21 one block from the State Capitol and the Cathedral of the Immaculate Conception as well as proximity 22 to downtown proved a central location for use by the Catholic community, political groups, and general 23 members of the public. To accommodate the mid-20th Century growth in membership and the 24 community's changing needs, the Knights of Columbus reconfigured the property in the early 1960s 25 adding a new event hall and creating an onsite parking lot. 26 c. Embodying distinctive visible characteristics of an architectural style or type; The event hall at 1555 North Grant Street, constructed in 1963, embodies the distinctive visible 27 28 characteristics of the Mid-century Modern architectural style. This is seen in the building's clean, 29 simple lines, flat roof, smooth exterior red brick surfaces, lack of embellishment, and its vertical 30 fenestration.

d. Being a significant example of the work of a recognized architect or master builder;

The event hall is a significant example of the work of recognized architect John F. Milan, as likely

Denver's earliest example of the use prestressed double tee concrete framing members.
