6. **General description of proposed ordinance including contract scope of work if applicable:**

The Urban Drainage and Flood Control District and the City and County of Denver would like to utilize \$250,000 in UDFCD funding to update the design of an open channel reconstruction project and fund right-of-way acquisition. The project goals are to remove approximately 19 structures from the 100-year flood plain; acquire the necessary properties; improve safety, recreation opportunities, wildlife habitat, and maintenance access; and create an amenity for the citizens of the City and County of Denver. This project is being managed through design by UDFCD. These funds are in addition to \$490,000 in CCD enterprise funds previously committed through the original agreement. This amendment will also change the language of the agreement to account for the potential of additional funds in future years.
