6 **For an Ordinance amending Ordinance Number 426, Series of 2007, as amended by**  
7 **Ordinance Number 335, Series of 2009, Ordinance Number 148, Series of 2010, and**  
8 **Ordinance Number 11, Series of 2011 designating the project to be undertaken and**  
9 **funded with the proceeds of the Better Denver bonds.**

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** That Section 3 of Ordinance Number 426, Series 2007, now reading, “Section 3.  
13 No changes can be made which affect the total funding amount for each purpose. Within each  
14 purpose, the expending authority may decrease the amount specified for any particular project by up  
15 to ten (10) percent of the total amount specified for the project in order to transfer moneys to other  
16 projects within the same purpose. Any other modifications will require an amendment of this  
17 Ordinance by the Denver City Council.”

18 is hereby amended to read as follows:

19 “Section 3. No changes can be made which affect the total funding amount for each purpose.  
20 Within each purpose, the expending authority may decrease the amount specified for any particular  
21 project by up to ten (10) percent of the total amount specified for the project in order to transfer  
22 moneys to other projects within the same purpose. **However, the expending authority may expend**  
23 **bond premium generated and interest earned, by purpose, on any project eligible to receive**  
24 **bond funding.** Any other modifications will require an amendment of this Ordinance by the Denver  
25 City Council.”
