19 payable to Johnathen Duran and his attorneys, Loevy & Loevy, in full payment and satisfaction of all  
20 claims asserted by Johnathen Duran in the civil action captioned Sara Fitouri, et al. v. City and  
21 County of Denver, et al., which was filed in the United States District Court for the District of Colorado,  
22 Case No. 20-cv-1922-RBJ-MEH and consolidated with Case No. 20-cv-1878-RBJ.

23 Payment is to be made upon the execution and delivery of such release or releases as is or  
24 are satisfactory to the attorney for the City and County of Denver.
