A BILL

For an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

WHEREAS, pursuant to 9.1.1 (C) and (D) of the Charter and Article I of Chapter 18, D.R.M.C., the Office of Human Resources has recommended to the City Council an amendment to the classification and pay plan governing the compensation of employees in the career service and certain employees not in the career service;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto**, the classification and pay plan is hereby amended by adding the following job titles and associated pay grades, to read as follows:

Marketing/Communications Professional I	615-A (\$39,911-\$58,270)
Marketing/Communications Professional II	808-A (\$49,850-\$79,760)
Marketing/Communications Professional II Hourly	808-A (\$49,850-\$79,760)
Marketing/Communications Specialist	811-A (\$60,898-\$97,437)
Marketing/Communications Manager	814-A (\$74,394-\$119,030)

Section 2. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto**, the classification and pay plan is hereby amended by abolishing the following job titles:

Job Title
Marketing/Public Relations Representative
Marketing/Public Relations Representative Hourly
Marketing/Public Relations Specialist
Marketing/Public Relations Administrator
Marketing/Public Relations Administrator Hourly

2 pay plan kept and maintained in the office of the Clerk and Recorder, as reflected at Clerk Filing
3 No. 13-500-G, and at the Office of Human Resources, and shall be available for public inspection
