Dear City Council Member:


There will be a Board of Equalization Hearing during your regular City Council meeting on September 20<sup>th</sup>, 2010 for the Group 1 Local Maintenance Districts (LMD's). During this regular meeting, City Council will adjourn as City Council, reconvene as the Board of Equalization (BOE) and will then hear appeals, if any, by owners of properties located in the following LMD's:

There will be a representative from the District Management Office at the meeting to respond to questions.

The due date of September 10, 2010 for receiving appeal letters for Group 1 has expired. Tax-exempt owners must request a reduction of this "special assessment". Prior reductions may not necessarily justify reductions in the current year. All reductions approved by City Council must be funded from the City's General Fund. *As of today, no appeal letters for Group 1 have been received.*
