A BILL

For an ordinance amending Ordinance No. 383, Series of 2014, concerning the Supplemental Appropriations from the General Contingency Fund to various departments.

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Section 3 of Ordinance No. 383, Series of 2014, is hereby amended to read as follows:

“Section 3. From the General Fund, Accounting No. 01010, out of moneys rescinded by Section 2 of this ordinance and not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 631, Series of 2013, and any supplemental appropriations or rescissions, there is hereby APPROPRIATED to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
