A BILL

For an ordinance making a supplemental appropriation from the General Fund Contingency to Community Planning and Development.

WHEREAS, Community Planning and Development needs additional budget to address the backlog of permits;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:
