CB14-0755 A bill for an ordinance designating certain properties as being required for public use and authorizing use and acquisition thereof by negotiation or through condemnation proceedings of easement and other interests as needed for the 33rd Street Outfall (31st and 36th Street Outfall Project).

Authorizes the Division of Real Estate to negotiate purchase or condemnation of all or any portion of property interest in nine (9) properties, including temporary easements, permanent easements, and license agreements for the construction of the 33rd Street Outfall (31st and 36th Street Outfall Project) in Council District 9. The Committee approved filing this bill by consent on 9-11-14.

CB14-0758 A bill for an ordinance relinquishing the easement reserved in Ordinance No. 92, Series of 1922.

Approves the permanent relinquishment of an easement located at 3420 West 17th Avenue, in Council District 1 (2013-0070-05). The Committee approved filing this bill by consent on 9-11-14.

CB14-0759 A bill for an ordinance vacating the alley between East Illif Avenue, East Wesley Avenue, vacated South Gaylord Street and South York Street, with reservations.

Approves the permanent vacation of an alley located near 2150 West Wesley Avenue in Council District 7 (2013-0294-04). The Committee approved filing this bill by consent on 9-11-14.

CB14-0760 A bill for an ordinance vacating the alley between 3422 West Conejos Place and 3430 West Conejos Place, without reservations.

Approves the permanent vacation of an alley located between 3422 West Conejos and 3430 West Conejos Place in Council District 1 (2014-0635-01). The Committee approved filing this bill by consent on 9-11-14.

CB14-0688 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Mental Health

Center of Denver to provide support services to the chronically homeless in Denver.

Amends the contract with the Mental Health Center of Denver to modify the budget from a cost reimbursement to a fee for service for housing, and treatment services for 75 chronically homeless individuals with co-occurring serious mental illness and substance use disorders (SOCSV-2013-14438-01). Amends the Classification and Pay Plan to add Library Aide at pay grade 219-Y and abolish the classification of Shelver at 601-C. The Committee approved filing this bill by consent on 9-11-14.
