**A BILL**

**For an ordinance making an appropriation in the Grant and Other Money  
Projects Fund.**

**WHEREAS**, the Colorado Convention Center Capital Fund, Accounting No. 38422, serves as a financial reserve for the Colorado Convention Center Expansion Project and the COP payment, as well as a source for other needed capital improvements; and

**WHEREAS**, there is currently cash available to support the Colorado Convention Center Expansion Project;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Grant and Other Money Projects Fund, Accounting No. 38000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1284, Series of 2021, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
