**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Colorado Health Foundation concerning the “Mayor’s Initiative to Expand Housing Vouchers and Day Shelter Services” program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement; and

**WHEREAS**, a new Special Revenue Fund, the Housing Stability Private Grants Fund, will be created in a forthcoming ordinance to administer private grants under the Department of Housing Stability, which is a new department in 2019;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement between the City and County of Denver and the Colorado Health Foundation, for the “Mayor’s Initiative to Expand Housing Vouchers and Day Shelter Services” program, which is identified as Grant Number 13470, a copy of which is duly filed with the City Clerk, Filing No. 201952882, be and hereby is approved in all respects.

**Section 2.** The payments made by the Colorado Health Foundation, to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of the “Mayor’s Initiative to Expand Housing Vouchers and Day Shelter Services” program, to be expended by the Director of Housing Stability and deposited in the Community Development Special Revenue Fund Series, is as follows:

4 to accomplish the purposes of this Resolution, including transferring the program and all related  
5 transactions to the new Housing Stability Private Grants Special Revenue Fund after it has been  
6 approved by City Council.
