ROAD, VACATED WEST 14TH AVENUE AND CANOSA  
COURT, SUBJECT TO CERTAIN RESERVATIONS.

WHEREAS, the Manager of Public Works of the City and County  
of Denver has found and determined that the public use, convenience  
and necessity no longer require that certain alley in the system  
of thoroughfares of the municipality hereinafter described and  
subject to approval by ordinance, has vacated the same with  
reservations hereinafter set forth; now, therefore,  
BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works  
in vacating the following described alley in the City and County  
of Denver and State of Colorado, to wit:

The alley between Lots 1 and 20, Jacobs Addition  
to Highland, lying between the southeasterly line  
of Morrison Road (County Road No. 6) and the  
westerly line of Lot 8, Ashton.

be and the same is hereby approved and the described alley is  
hereby vacated and declared vacated, provided, however, said  
vacation shall be subject to the following conditions and  
reservations:

That easements be and are hereby retained to protect the  
utilities in the vacated alley which utilities include power  
and telephone lines.
