

# **Nonprofit Vehicle Donation Program**

### **Program Summary**

The City and County of Denver's Nonprofit Vehicle Donation Program repurposes roadworthy vehicles that would otherwise be sold through auction, providing eligible nonprofits with vehicles for educational and instructional use. This supports workforce development while ensuring legal, safety, and operational standards.

### **Background:**

Councilwoman Torres collaborated with Denver's Department of General Services to create a formal vehicle donation program, filling a gap in current municipal code which did not allow donations. This program aligns with similar successful initiatives in other cities and organizations, demonstrating both feasibility and community impact.

#### **Ordinance Amendment:**

Current Denver Revised Municipal Code (D.R.M.C. Sec. 54-816) does not authorize vehicle donations. A proposed amendment will add donation to eligible nonprofits as an authorized method of impounded vehicle disposition, enabling the program's legal foundation.

### **Key Objectives:**

- Support vocational training through nonprofits and educational/governmental entities
- Create a legal framework for vehicle donation
- Maximize community benefit and minimize waste
- Ensure transparency and accountability

### **Eligibility:**

- IRS-registered nonprofits or government entities focused on education or workforce development in the City and County of Denver
- Must have secure facilities and instructional plans for the vehicles
- Proof of nonprofit or educational institute status and agreement with the City required

## Vehicles:

- Roadworthy, valued ≤ \$1,500, and legally cleared for donation
- Not from restricted sources or unsafe
- Held 30 days for owner reclamation before donation

#### **Program Details:**

Up to 100 vehicles donated annually, max 4 per nonprofit



- "As-Is" condition; donees handle towing, repairs, and title transfer
- Application reviewed and vehicles allocated by General Services

# **Budget & Oversight:**

- Minimal financial impact; manageable administrative workload
- Program governed by City ordinance amendment and legal agreements
