8 **For an ordinance approving and providing for the execution of a proposed**  
9 **Intergovernmental Agreement between the City and County of Denver and the**  
10 **State of Colorado, Department of Transportation, concerning the "Federal**  
11 **Highway Safety Improvement Program (HSIP) 2018 Package 2 City and County**  
12 **of Denver Traffic Signal Replacement " project and the funding therefor.**

15 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
16 Intergovernmental Agreement; and

17 **WHEREAS**, the traffic signal improvements will be located at 38<sup>th</sup> Avenue and Federal  
18 Boulevard, Kentucky Avenue and Federal Boulevard, Mississippi Avenue and Federal Boulevard,  
19 Jewell Avenue, and Federal Boulevard and Colorado Boulevard and Martin Luther King Boulevard;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
21 **DENVER:**

22 **Section 1.** The proposed Intergovernmental Agreement, under CFDA No. 20.205, between  
23 the State of Colorado, Department of Transportation, and the City and County of Denver, a copy of  
24 which is duly filed with the City Clerk, Filing No. 17-0554, be and hereby is approved in all  
25 respects.

26 **Section 2.** The payments made by the Colorado Department of Transportation to the City  
27 pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of  
28 the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18  
29 of the Revised Municipal Code of the City and County of Denver.
