Crime Prevention and Control Commission has contracted with the State Judicial Department to support probation officers and magistrates in Drug Court, expedite pre-sentence reports for persons in-jail custody (expedites sentencing by and average of 15 days per person), provide juvenile mental health and gang prevention services. The proposed contract provides for a cumulative total that exceeds the threshold contained in Section 3.2.6(E) of the Charter requiring City Council approval. The proposed amendment adds \$333,300.93 resulting in the current cumulative cost of \$1,401,936.08. Contract ends December 2010.
