If work under this Permit is not properly completed, this Permit shall become void. If work under this Permit is not commenced within one year from the date of issuance or, if after partial completion, the work is discontinued for a period of one year, this Permit shall become void. Failure to comply with this Permit may result in the imposition of civil penalties (up to \$10,000 per day) pursuant to DRMC 56-107. Disputes regarding this permit shall be resolved by administrative hearing pursuant to DRMC 56-106.

Final Development Services, receipt and approval of "As-Built" plan and profile drawings, and receipt of a Certificate of Inspection from the Design Engineer, for the new private on-site sanitary sewer (Master Project 2006-0366/PR-2009-044), are required PRIOR TO ANY SANITARY BUILDING SEWER CONSTRUCTION OR CONNECTIONS. ELC 11/13/2009

The cut-off of the existing sewer line must be inspected prior to, or at the same time as, the new sewer line and connection. The cutoff must be made at property line or as far downstream as possible.

The new building sewer line(s) and connection(s) must be inspected and water tested by PW WMD Plumbing Inspection. Installation must conform to PW WMD standards regarding workmanship and materials, to include the use of Class B bedding material conforming to ASTM C-33, gradation size 67. All work must be done by a properly licensed Plumbing or Sewer Contractor and the licensed Plumbing or Sewer Contractor must call PWPO at 303-446-3759 with valid license and permit numbers, no later than 3:30 P.M. on the previous business day, to schedule inspections. ELC 11/13/2009

Any portion of the building sewer being built over, or any portion within two (2) feet of a building, must be installed with approved material (Schedule 40 PVC, ABS/DWV, or Cast Iron pipe). All new sewers beyond two (2) feet from the building must be inspected and approved by PW WMD Plumbing Inspection. ELC 11/13/2009

The properly licensed sewer contractor must coordinate cleanout locations with the PW WMD Plumbing Inspector. An approved type of wo-way cleanout shall be installed outside of the building near the connection between the building drain and building sewer, on ALL building sewer lines exiting the building, and extended to grade. Additional cleanouts shall be installed at intervals not to exceed 100 feet and for each te horizontal change in direction exceeding 135 degrees. ELC 11/13/2009

3.T. arraimberg, with Denver Water, must be contacted at (303) 628-6112, for direction and assistance regarding the recirculation of cooling water. ELC 11/13/2009

All construction activities associated with this permit are subject to the conditions and requirements of Erosion & Sediment Control / Construction Activities Stormwater Discharge Permit #201001028, issued for DENVER ZOO/ASIAN TROPICS. ELC 02/11/2010

A minimum of a 330-gallon, two-compartment, sand and oil interceptor shall be installed to conform with PW, WMD Standard Drawing #S-965. An approved two-way cleanout will be installed along the interceptor waste line leaving the interceptor unit. The properly licensed Plumbing Contractor must call PWPO at 303-446-3759 to schedule the required inspection. AdeS 03/24/2010

Routing of the waste lines directed to the minimum 330-gallon sand/oil interceptor must be inspected and approved by the Denver Building inspection Division. The licensed Plumbing Contractor must contact the Denver Building Inspection Division to schedule the required routing nspection. AdeS 03/24/2010

All storm work must be completed and inspected and "As-Built" record drawings and a Certificate of Inspection (prepared by a Colorado icensed P.E.) for the storm work (#2006-0366 / PR-2009-045 / PR-2007-126 / PR2006-079) must be submitted to Development Services, 201 W. Colfax Ave., Dept. 203, Denver, CO 80202, and approved, prior to validation of a Temporary or Permanent Certificate of Occupancy. 32/17/2010 bb

All downspouts extenders, splash blocks, sump pump &/or pit discharge pipes/ lines, and private sidewalk chases must be installed & will be nspected, along with the Finished Grading and Graded Swales, at the time of the Wastewater TCO or CO inspection. All discharge points for downspouts and sump pump lines must be at least 6-inches from alleys, 3-feet from side-yard property-lines, and 8-feet from front-yard property-lines.

No underground piping for storm drainage (no area drains, no underground downspout extenders, etc.) and no window well, below grade patios or below grade walk-out area drains are authorized under this permit. Ground water discharge is also not authorized under the terms of this permit.

Proper drainage as required by Sec. 59-92(6) of the RMC: The contractor must grade the lot to meet the following four conditions at a minimum:

- 1. Adequate drainage away from the foundation must be provided.
- 2. Off-site drainage flowing onto the site is conveyed safely through the site to a reasonable outfall point.
- 3. On-site drainage must be conveyed off the site in the direction of the historic drainage patterns to a reasonable outfall point.
- 4. Tard grading must not push additional drainage across the shared lot line. Window wells must have an expanded on-site swale adja. It to compensate for the area blocked by the window well.
