The number of classes and school locations is to be decided by the Director of the GRID project in agreement with the Chief Juvenile Probation Officer; serves as the project's community gang prevention resource officer providing resource navigation and connection to high-risk youth and families and collects data relevant to the work completed and provide such data to GRID on a quarterly basis.

**Gang and Gun Offender Case Management - 1 FTE Probation Officer**

Provides case management services to high-risk juvenile offenders that are associated with gangs and have a sustained allegation related to either possession or use of a firearm, during the course a crime, who are placed under Denver Juvenile Probation supervision per order of Denver Juvenile Court.
