#### AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City") and ACTIVE NETWORK, LLC (successor in interest to The Active Network, Inc.), a Delaware corporation registered to do business in Colorado, whose primary address is 10182 Telesis Court, San Diego, California 92121 ("Vendor" or "TAN" or "Active").

#### WITNESSETH:

**WHEREAS**, the Parties entered into an Agreement dated February 03, 2014 (the "Agreement"), to provide activity and participant management for activity registrations, facility reservations, membership management, league scheduling, point of sales, marketing, donations, reports and public access; and

WHEREAS, ACTIVE NETWORK, LLC, is the successor to THE ACTIVE NETWORK, INC.; and

WHEREAS, the Parties wish to amend the Agreement to revise Exhibit 2, Services, as follows; and

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- **1.** Exhibit 2, SERVICES, of the Agreement is revised as follows:
- (i) Pages 5-28 are deleted in their entirety and replaced with the attached Exhibit 2A;
- (ii) Pages 39 through 40 are deleted in their entirety and replaced with the following language: ON-SITE SERVICE FEES-Airfare has been approved for 10 trips with a "Not to Exceed" price of \$10,000. The City will reimburse the actual cost of airfare upon prior approval of the actual cost and not the \$10,000.

2. This First Amendatory Agreement may be executed in counterparts, each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the same instrument.

3. The Agreement, as amended, is hereby assumed by Vendor, affirmed and ratified by the parties in each and every particular. In the event any of the terms and conditions of the Agreement conflict with the terms and conditions of this Amendatory Agreement, the terms and conditions of this Amendatory Agreement shall prevail only as to the subject matter expressly stated herein.
