Ordinance no. 762, series 2020 established fund number 38760 for the "Central Branch Library Renovation" program for the purpose of receiving funds from the Denver Public Library Friends Foundation, per a Project Funding Agreement, for capital expenditures for the Central Branch Library Renovation project supported by the Elevate Denver Bond. This bill request seeks to change the name and expand the scope of the SRF to allow new revenue and capital expenditures beyond the time and scope of the original agreement and include all DPL library locations. This amendment will change the fund name to the "Denver Public Library Renovations" SRF and modify the allowable revenue and expenditures to include the use of Denver Public Library Friends Foundation fundraising for capital projects at any Denver Public Library location.

This request is a companion to the annual Long Bill and allows for an administrative action needed to implement the 2026 budget as adopted.
