Dear Councilmembers,

I'm writing on behalf of Lupus Colorado to share why the Xcel Energy franchise agreement is so important to the families we serve. We partner with Energy Outreach Colorado to provide emergency utility assistance, and funding from Xcel truly makes the difference between safety and crisis for the people we help.

Just this year, we've been able to keep the lights and heat on for 258 Xcel customers. One story stands out: a patient in our community who relies on home dialysis to keep their kidney function called us in tears. Their electricity had been shut off, and without power their dialysis machine couldn't run. They were terrified, and their only other option was to head to the emergency room, an option that would have placed unnecessary stress on both the patient and the hospital. Because of Xcel's support, we were able to step in, get their power turned back on the very same day, and keep them safe at home. For a person living with lupus the opportunity to stay home and manage their care in comfort is a luxury most of us take for granted.

Moments like this happen more often than most people realize. Right now, resources are scarce and the need for help is growing. Xcel Energy's partnership allows us to respond quickly when lives are literally on the line. We hope you'll keep that impact in mind as you consider renewing the franchise agreement; it's not just about utilities, it's about protecting the health and dignity of people in our community.

At Lupus Colorado, our mission is to improve the quality of life for all people affected by lupus and to ensure they have the resources, support, and hope they need to navigate this disease.

Partnerships like the one with Xcel make this mission possible.

Dear Members of Denver City Council,

On behalf of Energy Outreach Colorado (EOC), I respectfully urge your approval to place the new franchise agreement between the City and County of Denver and Xcel Energy on the November ballot.

Since its inception in 1989, EOC has partnered with Xcel Energy to ensure all Coloradans,

especially those facing economic hardship, can afford the energy they need to remain safe and healthy at home. This 35-year collaboration is foundational to our ability to leverage public, private, and philanthropic resources to advance energy affordability, efficiency, and equity across the state.

In 2024, EOC provided \$20.6 million in direct bill payment assistance to Xcel Energy customers, serving nearly 24,000 Colorado households. Denver residents represented a significant portion of that impact: we delivered \$5.8 million in assistance to 6,567 households in the city, with an average benefit of \$883 per home. We have also enrolled more than 500 Denver households in Community Solar Gardens, reducing their electricity bills by up to 50 percent.

Our partnership with Xcel Energy extends well beyond emergency assistance. We connect households to Xcel's Percent of Income Payment Program (PIPP), which supports long-term affordability. We also implement energy efficiency upgrades in residences and nonprofit facilities under contracts with Xcel Energy. We also work closely with the City's Office of Climate Action, Sustainability and Resiliency (CASR) and the District One Energy Office (D-ONE), aligning programs and resources to maximize impact.

Our work is grounded in the lived experiences of the families we serve. When Delicia and her nine-year-old daughter Rylee moved to Denver earlier last year, they were navigating financial hardship and health challenges. After learning about our Emergency Bill Pay program through 211, Delicia received assistance that helped stabilize her home. "It was truly a stress reliever," she shared. That support allowed her daughter to focus on school and dance and offered a sense of security during a difficult transition.
