CR14-1090 A resolution laying out, opening and establishing as part of the City street system a parcel of land as West Dakota Avenue between South Cherokee Street and South Broadway.

Dedicates land as public right-of-way at the intersection of West Dakota Avenue between South Broadway and South Cherokee Street in Council District 7. The Committee approved filing this resolution by consent on 12-18-14.

CR14-1108 A resolution approving the Mayor's reappointments to the Denver Union Station Project Authority Board of Directors.

Accepts \$6,172,569 in U.S. Department of Labor, Employment and Training Administration grant funds entitled H1-B Ready-to-Work (HG-26659-15-60-A-8). The last regularly scheduled Council meeting within the 30-day review period is on 1-26-15. The Committee approved filing this bill by consent on 12-24-14.

CB14-1111 A bill for an ordinance approving a proposed First Amendatory Agreement between the City and County of Denver and ISS Facility Services, Inc. concerning janitorial services at Denver International Airport.

Adds \$1 million to the contract with ISS Facility Services (for a new contract total of \$97,003,655) for additional janitorial services at the Concourse West expansion at Denver International Airport (201206835). CB14-1132 A bill for an ordinance approving a proposed Grant Amendment between the City and County of Denver and the State of Colorado related to Transportation, Community, and System Preservation Program at Denver International Airport.

Amends a grant agreement with the Colorado Department of Transportation (CDOT) by adding \$124,600.25 for a new contract total of \$623,001.25 to provide for joint selection of a contractor to undertake the Denver International Airport Aerotropolis planning (201312131-01). CB14-1104 A bill for an Ordinance approving the proposed 2801 Welton Street Property Tax Increment Area Cooperation Agreement between the City and County of Denver and The Denver Urban Renewal Authority.

Approves the 2801 Welton Street Property Tax Increment Area and Sales Tax Increment Area Cooperation Agreement between the City and the Denver Urban Renewal Authority for the 2801 Welton Street Project to establish the parameters for property and sales tax increment financing in Council District 8. The last regularly scheduled Council meeting within the 30-day review period is on 12-20-15. The Committee approved filing this bill at its meeting on 12-16-14.

CB14-1110 A bill for an ordinance establishing an "Assistance Incentives Program" fund in the Human Services Special Revenue Fund and the means for authorizing expenditures from such fund.

Establishes the Assistance Incentives Program Special Revenue Fund for Denver Department of Human Services for incentives received from the State of Colorado for support activities for Medicaid and other assistance programs. The Committee approved filing this bill by consent on 12-18-14.

CB14-1115 A bill for an ordinance approving a Purchase and Sale Agreement between the City and County of Denver and Belle Haven Realty Company for property located at 2100 31st Street.

Approves a \$5,338,820 purchase and sale agreement between the City and Belle Haven Realty Co. for land and improvements at 2100 31st Street for a new service center for City fleet and the Electronic Engineering Bureau (201419298). Relinquishes easements created by Ordinance No. 77, Series of 1968, at 830 Wyandot Street in Council District 9. The last regularly scheduled Council meeting within the 30-day review date is on 1-20-15. The Committee approved filing this bill by consent on 12-18-14.

CB14-0963 A bill for an ordinance changing the zoning classification between 17th Avenue, Conejos Place, Stuart Street and Perry Street - South Sloan's Lake General Development Plan boundaries.

Approves a map amendment to rezone property located between 17th Avenue, Conejos Place, Stuart Street and Perry Street from C-MX-5 (Urban Center, Mixed Use, 5 stories) to C-MX-5/proposed DO-5 in Council District 1. CB14-0940 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Savio House to provide treatment and support services through the Core Services Program.

Approves a no-cost amendment to the contract with Savio House to add life skills services to the scope of work and Health Insurance Portability and Accountability Act (HIPAA) language (SOCSV-2014-16375-01). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill by consent on 11-13-14.

CB14-0995 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and the Colorado

Coalition for the Homeless to provide outreach and housing placement services to homeless youth and adults.

Amends a contract with The Colorado Coalition for the Homeless to extend the term through 12-31-15 and add \$1 million, for a new total of \$2 million, to provide outreach services to homeless youth and adults, making at least 6,500 contacts with homeless individuals during the new term (SOCSV-2013-14442-01). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill by consent on 11-26-14.

CB14-1060 A bill for an ordinance approving an Agreement with Colorado Dental Service, Inc. dba Delta Dental of Colorado for the City and County of Denver.

Approves an agreement with Delta Dental of Colorado to provide dental insurance in 2014 to eligible employees with a contract amount not to exceed \$10,408,789 (CSAHR-201417758-001). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill by consent on 12-16-14.

CB14-1061 A bill for an ordinance approving an Agreement with Denver Health Medical Plan, Inc. to provide medical insurance in 2014 for the City and County of Denver.

Approves an agreement with Denver Health Medical Plan, Inc. to provide medical insurance in 2014 to eligible employees with a contract amount not to exceed \$4.5 million (CSAHR-201417752-00). CB14-1063 A bill for an ordinance approving an Agreement with Kaiser Foundation Health Plan of Colorado for Group 74 – Fire for the City and County of Denver.

Approves an agreement with Kaiser Foundation Health Plan of Colorado to provide medical insurance in 2014 to eligible employees of the Denver Fire Department with a contract amount not to exceed \$16.044 million (CSAHR-201417747-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill at its meeting on 12-16-14.

CB14-1064 A bill for an ordinance approving an Agreement with Kaiser Foundation Health Plan of Colorado, relating to health insurance coverage for the Denver Police Department.

Approves an agreement with Kaiser Foundation Health Plan of Colorado to provide medical insurance in 2014 to eligible employees of the Denver Police Department with a contract amount not to exceed \$12.2 million (CSAHR-201419380-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill at its meeting on 12-16-14.

CB14-1065 A bill for an ordinance approving an Agreement with Standard Insurance Company for the City, Police, and Fire Departments.

Approves an agreement with Standard Insurance Company to provide term life insurance, additional life insurance, short-term and long-term disability insurance and dependent life insurance in 2014 to eligible employees with a contract amount not to exceed \$7.667 million (CSAHR-201417731-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill by consent on 12-16-14.

CB14-1066 A bill for an ordinance approving an Agreement with United Healthcare Services, Inc. dba United Health Group for the City and County of Denver.

Approves an agreement with United Healthcare Insurance Company to provide medical insurance in 2014 to eligible employees with a contract amount not to exceed \$50.941 million (CSAHR-201417748-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-20-15. The Committee approved filing this bill by consent on 12-16-14.

Approves a contract with PCL Construction Services, Inc. for \$8.5 million through 6-30-16 for the full design and construction of the new Fire Station 35 at Denver International Airport (201314429). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill on consent on 12-11-14.

CB14-1054 A bill for an ordinance approving a proposed Fifth Amendment to Permit Agreement for Multi - purpose Permit - Ref. No. 300 between the City and County of Denver and Park Creek Metropolitan District for general construction traffic access, ingress, and egress at the former Stapleton site.

Approves an amendment to the Multi-Purpose License (Multi-Purpose Permit Ref. 300) to the Park Creek Metropolitan District by extending the license by three years four months for a new expiration date of 5-15-18 and to allow the developer to utilize airport property for construction activities to facilitate the development at Stapleton for the areas south of Smith Road (AC13010(5)). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-14. The Committee approved filing this bill on consent on 12-11-14.

CB14-1055 A bill for an ordinance approving a proposed Fourth Amendment to Permit Agreement for the use of existing utilities, Ref. No. 400 between the City and County of Denver and Park Creek Metropolitan District at the former Stapleton site.

Approves an amendment to the Multi-Purpose License (Multi-Purpose Permit Ref. 400) to the Park Creek Metropolitan District by extending the license by three years four months for a new expiration date of 5-15-18 to allow the developer to utilize airport property for construction activities to facilitate the development at Stapleton for the areas south of Smith Road (AC34006(4)). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-14. The Committee approved filing this bill on consent on 12-11-14.

Finance & Services

CB14-1024 A bill for an ordinance approving the exchange of City-owned land at 1201 North Perry Street to allow for the relocation of an alley in the development of 1209 North Perry.

Approves the exchange of 2,300 square feet of City-owned land at 1201 North Perry for 2,210 square feet of privately-owned land (known as a portion of the address of 1209 North Perry) to allow for the relocation of an alley in the development of 1209 North Perry in Council District 1. The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 12-4-14.

CB14-1049 A bill for an ordinance authorizing the transfer of accrued investment earnings from the 1989 Colorado Convention Center Replacement Fund to the Colorado Convention Center Capital Maintenance Fund.

Transfers \$210,773 in accrued investment earnings from the 1989 Colorado Convention Center Replacement Fund (38095) to the Capital Improvement Fund (34080) for Convention Center capital maintenance. The Committee approved filing this bill by consent on 12-4-14.

Safety & Well-being

CB14-0973 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and Mental Health Center of Denver to provide support services to the chronically homeless in Denver

Amends a contract with the Mental Health Center of Denver to add \$830,000 for a new total of \$1.66 million to provide housing and treatment services for 75 chronically homeless individuals with mental health and sometimes co-occurring substance use disorders (SOCSV-2013-14438-02). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 11-13-14.

CB14-0993 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and The Colorado Coalition for the Homeless to provide housing placement and treatment services to homeless adults in Denver.

Amends a contract with The Colorado Coalition for the Homeless to extend the term through 12-31-15 and add \$325,000 for a new total of \$650,000 to provide housing placement and treatment services for 60 chronically homeless adults in Denver (SOCSV-2013-14439-01). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill at its meeting on 12-9-14.

CB14-1000 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Volunteers of America Colorado Branch to provide on-call emergency shelter to Denver's homeless.

Amends a contract with Volunteers of America Colorado Branch to add \$416,000 for a new total of \$832,000, and extend the term one year through 12-31-15 to provide housing for families and single women when all of the City's emergency shelter beds are full, and to add Health Insurance Portability and Accountability Act (HIPAA) language (2013-14480-01). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 11-26-14.

CB14-1039 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and The Salvation Army to oversee emergency shelter operations for homeless men.

Amends a contract with The Salvation Army to add an additional \$380,000 for a new total of \$710,000 and extend the term through 12-31-15 to provide emergency shelter for up to 200 homeless men per night at the Crossroads Shelter in Council District 9 (SOCSV-2013-14454-02). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 12-11-14.

CB14-1077 A bill for an ordinance authorizing expenditures in the Human Services Special Revenue Fund based on a letter of intent from the State of Colorado to award funding for the "Community Services Block Grant FY15-16" program.

Appropriates \$506,259.50, which is 50% of the grant award for the 2015-2016 Community Services Block Grant based on a Letter of Intent provided by the Colorado Department of Local Affairs, to continue essential services to addressing poverty and homelessness. The Committee approved filing this bill by consent on 12-11-14.

CB14-1085 A bill for an ordinance approving a proposed Fifth Amendatory Agreement between the City and County of Denver and Northeast Denver Housing Center, Inc., to modify the terms and conditions of the Loan Agreement.

Amends an existing contract with Northeast Denver Housing Center, Inc. by increasing the subordination level on a City loan from \$500,000 to \$700,000 due to refinance of its debt in order to make substantial repairs to the roof, common areas, and interiors (GE7Y034). The last regularly scheduled Council meeting within the 30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 12-11-14.

CB14-1086 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Renaissance Housing Development Corporation to modify the terms of the Loan Agreement.

Amends a contract with Renaissance Housing Development Corporation (Colorado Coalition for the Homeless) to increase the City's subordination amount from \$15 million to \$17.5 million in order to match the increase in the first loan with US Bank (OEDEV-201416398-00). The last regularly scheduled Council meeting within the

30-day review period is on 1-12-15. The Committee approved filing this bill by consent on 12-11-14.
