6 For an ordinance approving a proposed Development Project Funding
7 Agreement (Denver Pavilions located at 500 16th Street, Denver, Colorado)
8 between the City and County of Denver and Denver Downtown Development

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** The proposed Intergovernmental Agreement between the City and County of
13 Denver and Denver Downtown Development Authority, in the words and figures contained and set
14 forth in that form of agreement available in the office and on the web page of City Council, and filed
15 in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, under City
16 Clerk's Filing No. 202581850, is hereby approved.

17 **Section 2.** This proposed Ordinance shall only be effective upon: 1) Council's approval, and
18 the legal effectiveness, of Ordinance No. 914, Series of 2025 in accordance with Section 3.3.5 of
19 the City Charter; and 2) the successful closing of the financial transactions contemplated in
20 accordance with Ordinance No. 914, Series of 2025 to provide sufficient appropriated funding for the
21 transaction contemplated in this Ordinance in conformance with Section 7.2.2 of the City Charter. If
22 both of the conditions precedent referenced in the previous sentence are not fully satisfied by
23 **December 19, 2025**, then this Ordinance shall be of no legal force or effect and shall be void *ab
initio*."
