18 **Section 1.** The proposed Grant Agreement, between the Colorado Office of the Governor
19 and the City and County of Denver, which is identified as Grant Number JHZYLXQAKY33, a copy
20 of which is duly filed with the City Clerk, Filing No. 202474195, be and hereby is approved in all
21 respects.

22 **Section 2.** The payments made by the Colorado Office of the Governor to the City pursuant
23 to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to
24 Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
25 Municipal Code of the City and County of Denver.


26 **Section 3.** That it be and is hereby found and determined that the budget summary of said
27 Program, to be expended by the Director of the Office of Children's Affairs:
