**Section 3.** Monies described in Section 2 of this Ordinance are designated for the specific purpose of repairs, improvements and betterment of the Hamilton Building's vapor and water barrier systems. After the vapor and water barrier system work is completed, monies are designated for capital improvement first and capital maintenance if any such receipts remain.

receipts received for said purpose shall be deposited into the Treasury of the City and credited to

Grant/Other Capital Projects Fund No. 38000 which is set forth and described in Section 20-18 of
