A BILL

For an ordinance amending Ordinance No. 288, Series of 1984, to change the name of the “Denver Employment and Training Administration” Fund and clarify the allowable expenditures.

WHEREAS, the “Denver Employment and Training Administration” Fund was established in Ordinance No. 288 in the Series of 1984 and is administered by the Office of Economic Development, currently known as Denver Economic Development and Opportunity; and

WHEREAS, the Denver Economic Development and Opportunity uses this fund to administer programs related to training, outreach, and support for entrepreneurs, small businesses, and workforce development efforts for youth and adults; and

WHEREAS, the Denver Economic Development and Opportunity desires to change the name of the fund to the “Business and Workforce Development Training, Support and Outreach” Fund and amend the original ordinance to clarify how the fund is currently used;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The Special Revenue Fund currently known as the “Denver Employment and Training Administration”, Accounting No. 17904, established through Ordinance No. 288, Series of 1984, shall henceforth be known as the “Business and Workforce Development Training, Support and Outreach” Fund.

Section 2. The portion of Section 2 of Ordinance No. 288, Series of 1984, now reading:

“Expenditures are hereby authorized from the Economic Opportunity Special Revenue Fund (Auditors No. 1700) in the amount not to exceed the total deposits described in Section 1 of this ordinance, to be expended for the “DETA Special Projects” program, Auditor’s No. 1724-9510, by the Mayor or his lawful successor or duly authorized agents.”

Is hereby amended to read as follows:

“Expenditures are hereby authorized from the Economic Opportunity Special Revenue Fund, Accounting No. 17000, in the amount not to exceed the total deposits described in Section 1 of this ordinance, to be expended for the “Business and Workforce Development Training, Support and Outreach” Fund, Accounting No. 17904, by the Mayor or his lawful successor or duly authorized agents. Allowable expenses include but are not limited to the costs to administer programs related to training, outreach, and support for entrepreneurs, small businesses, and workforce development efforts for youth and adults.

Section 3. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
