## Executive Summary

This proposed ordinance would approve the termination and dissolution of the 22<sup>nd</sup> Street and Park Avenue West Pedestrian Mall local maintenance district (“22<sup>nd</sup> Street and PAW LMD”). The 22<sup>nd</sup> Street and PAW LMD is located along both sides of 22<sup>nd</sup> Street from Blake Street to Stout Street; and along both sides of Park Avenue West from Vacated Potter Court to Stout Street, in Council District 9. The transfer of the 22<sup>nd</sup> Street and PAW LMD’s remaining funds, after payment of outstanding expenses, shall be to the Ballpark Denver General Improvement District (“Ballpark Denver GID”). These funds shall only be used within the property formerly located within the 22<sup>nd</sup> Street and PAW LMD.

### Background

The 22<sup>nd</sup> Street and PAW LMD was created by Ordinance No. 1090, Series of 1994. The purpose of the 22<sup>nd</sup> Street and PAW LMD is for the continuing care, operation, repair, maintenance and replacement of public improvements. The district’s public improvements include:

- Trees
- Tree grates
- Irrigation
- Decorative pedestrian lights
- Electrical power

### Reason for Dissolution

City Council approved Ordinance No. 766, Series of 2024 (“Creation Ordinance”), which created the Ballpark Denver GID and was later approved by the electors of said district voting for its organization by a majority of the votes cast for the organization at an election held on November 5, 2024, as provided in Part 6 of Article 25 of Title 31, C.R.S.

All the property contained within the 22<sup>nd</sup> Street and PAW LMD is encompassed within the Ballpark Denver GID boundary. To avoid the duplication of services, the Ballpark Denver GID has the capability to assume responsibility from the 22<sup>nd</sup> Street and PAW LMD for the continuing care, operation, repair, maintenance and replacement of the public improvements for which the 22<sup>nd</sup> Street and PAW LMD is responsible and located within the Ballpark Denver GID boundary.

In accordance with Section 21 of the Creation Ordinance, the Executive Director of the City’s Department of Transportation and Infrastructure desires to terminate and dissolve the 22<sup>nd</sup> Street and PAW LMD and transfer any surplus funds of the 22<sup>nd</sup> Street and PAW LMD, following payment of outstanding expenses that may be necessary to wind up its business, to the Ballpark Denver GID, all in conformance with this proposed ordinance.
