Official Map Amendment to rezone approximately 0.22 acres of property located at 1709 North Williams Street from B-2 WVRS to G-MS-3 in the City Park West neighborhood.

1. Notice of receipt of the application was sent on August 6, 2024.
2. Notice for the Planning Board Public Hearing was sent on December 3, 2024.
3. Planning Board voted unanimously to recommend approval of the application on December 18, 2024, with no speakers offering public testimony at the Planning Board hearing.
4. Applicant contacted Council District 10 prior to submitting their application.
5. To date, staff has received 8 comments in support and 22 comments in opposition to the proposed rezoning. Comments in support expressed anticipation for new residential opportunities in the neighborhood, while comments in opposition expressed concern regarding demolition of a unique (but non-historic) structure and existing commercial space. Applicant completed a mediation process with the City Park West RNO and neighboring property owner to address issues raised in public comments.
