A BILL

For an ordinance making a supplemental appropriation to transfer cash to the Business Incentive Fund.

WHEREAS, City Council has previously approved transferring cash from the General Fund Contingency to the Business Incentive Fund; and

WHEREAS, that transfer was incorrectly appropriated in the Office of Economic Development's General Fund budget; and

WHEREAS, the cash was not transferred to the Business Incentive Fund; and

WHEREAS, the Office of Economic Development requires the cash transfer for contractually obligated commitments;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

From the General Fund, Accounting No. 01010, out of monies rescinded in Section 1 and not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1032, Series of 2016, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:


