Supports business recruitment, retention, and expansion. Builds Denver's capacity to engage with and secure investment from global markets. Leads innovation & entrepreneurship initiatives.

### Division of Small Business Opportunity (DSBO)

Creates and expands contract opportunities for small, minority, and women-owned businesses.

#### **Executive Office**

Drives overall strategic planning, agency operations, communications, and personnel management.

#### Denver Workforce Development

Connects employers to a skilled talent pipeline. Connects jobseekers to employment and training opportunities. Houses the Denver Construction Careers Program.

### **Tools to Support Small Businesses: Access to Capital & Financial Support**

### **Small Business Lending**

• Gap financing for new businesses seeking to launch operations or for existing small businesses seeking to grow operations and create jobs in our community

### **Business Impact Opportunity (BIO) Fund**

 Business stabilization grants for small, neighborhood-serving businesses negatively impacted by City-funded construction projects of significant size and duration

### **Financial Readiness**

 DEDO's ARPA-funded technical assistance program (provided through its partner Mile High United Way) delivers free financial readiness workshops and 1:1 assistance to businesses seeking to become loan-ready and prepared to access and apply for grants and loans





### **Tools to Support Small Businesses: Access to Capital & Financial Support**

#### **Business Façade Improvement Program**

 Financial assistance to small businesses in Denver to enhance the exterior appearance of their buildings. This program aims to revitalize commercial corridors by improving the visual appeal of business properties, which in turn helps attract customers and stimulates local economies

### **Enterprise Zone**

 Program that unlocks state income tax credits for activities such as job creation, job training, investment in business personal property, and more for businesses located in the designated enterprise zone in Denver

#### **Business Investment Program**

 Program that unlocks local Business Personal Property Tax credits for new or expanding businesses





### **Tools to Support Small Businesses: Technical Assistance**

#### **Business Advising**

 One-on-one advising services offered to businesses to share and connect them to available resources and partners

### Legacy Business Program

 Program acknowledging and supporting Denver businesses that are longstanding, independent and/or locally owned that contribute to community character and vitality and hold cultural significance

### **Small Business Certification Program & City Contract Navigation Support**

 These programs help minority and women-owned businesses compete for and win city procurement contracts

#### **Family Business Preservation Program & Business Cooperative Support**

• These programs serve family-owned businesses and businesses interested in forming a cooperative with technical assistance that enables them both to sustain current operations and prepare for succession planning and ownership transition





### **Tools to Support Small Businesses: Workforce Development**

#### **Recruitment & Screening of Job Candidates**

- Consultatory services to help small businesses hire, train, or retain staff
- Company-specific recruitment events and job fairs to help establish employer presence in Denver and reach candidates actively searching for employment
- Assistance with helping employers maximize the Connecting Colorado job board for job postings and screen job candidates in the Connecting Colorado system
- Assessment services that facilitate the candidate screening process for employers

### **Sector Partnerships**

 Industry-specific meetings among employers and training providers to identify needed skills & collectively address any skill gaps in the Denver workforce

#### **Job Creation Subsidies**

 Job creation subsidies for employers interested in training pre-screened job candidates, including support for businesses interested in pursuing an apprenticeship model and on-the-job training

### **Global Landing Pad**

 An immersive, three-day, in-person program designed to provide scaling foreign businesses with the runway they need to successfully enter the U.S. market

### **Introductions & Connections**

• Concierge services which includes introductions to strategic partners, hosting international delegations, consulting with international businesses, and active participation in internally-focused roundtables and conference planning

#### **Market Research**

• Conduct market research to help a global business validate that Denver is a viable location for their US expansion plans

#### **Programs already highlighted**

• Tax Credit programs, Small Business Loans, Workforce Development Services, FREE co-working space, 1:1 business advisory services, site selection

### Denver StartUp Academy

• A six-week virtual program designed to provide early-stage entrepreneurs the foundational tools to successfully "start-up" in the City and County of Denver

### **Business Advising & Start-up guide**

- 1:1 business advising to share resources and connect budding entrepreneurs to any resources available
- A multi-lingual, step-by-step guide through city agencies and processes available in English, Amharic, Arabic, Dari, Nepali, Pashto, Somali, Spanish, and Vietnamese

### **Park Hill Innovation Hub**

• FREE co-working space for entrepreneurs and startups

### **Denver ScaleUp Network**

• Annual post-accelerator program to support a cohort of small, diverse and emerging Denver CEOs with solving their key strategic challenges to growth.

### **Tools to Attract Large Employers**



#### Site Selection Assistance & Data Analysis

 Services and information provided to companies considering Denver to make a case for a Denver location and measure the needs of a new project against the merits of potential locations

#### **Philanthropic Connections / Civic engagement**

 Connections to civic partners offered to companies new to Denver to accelerate their entry to our community and to provide volunteer opportunities for their workforce

#### **Business Incentive Fund**

 Performance-based incentives to win competitive and catalytic projects with significant associated capital investment or job creation and other community benefits

#### **Retail Sales Tax Sharing**

 Performance-based incentives to attract anchor retailers to new & existing retail locations that serve the needs & desires of neighborhoods & visitors while increasing Denver's retail sales tax revenue

### **Our Impact**



**\$25M,** representing **3,800+** BIO Fund **grants**, has been awarded to Denver's most vulnerable small businesses since 2019 248 business applications have been qualified for BIP, which influenced the retention and creation of over 50,000 jobs, since program launch in 2012 269 Enterprise Zone program participants reported 3,944 additional jobs at their EZ certified sites, \$169M in capital investment and \$30M in job training (2024)

DenSUN has supported **112** entrepreneurs whose companies raised \$445.5M in revenue, are worth a combined \$746 million, and have created 1,325 jobs since 2012

The Global Team welcomed 6 new countries represented by Honorary Consuls and supported the business case for new nonstop international flights

400 foreign business prospects with **100 landing successfully in Denver** since 2018
